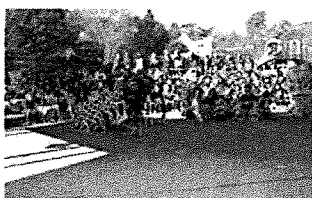

FAMILIES MAY OBJECT TO DISCLOSURE OF STUDENT DATA BY 4/1/16

The California Department of Education (CDE) is currently involved in a lawsuit in which the court ordered CDE to produce confidential student information related to all students who have attended a California school since January 1, 2008. **This order may result in a release of your student's confidential information.** To object to this release of information, parents must fill out and mail an objection form to the court no later than April 1, 2016.
