January 30, 2021

**A. OPENING CEREMONY**

**1. Meeting Protocol Under Covid-19**

The Board President announced meeting protocols under Covid-19 which prohibit large gatherings. This protocol includes procedures for the public to participate by observing the meeting on Zoom or calling in to offer public comment.

**2. Attendance/Call Meeting to Order**

**D. DISCUSSION/ACTION ITEMS**

**1. Grand Jury Report: Selection of Legal Counsel**

Mr. Bausch noted that the Board will be asking a very limited question of any attorney selected and that the Board might be advised to use a firm different from the administration because of a potential conflict of interest. The attorney will be asked to review the Board's final draft before it is submitted to Judge Duffy and the Grand Jury. President Arend suggested the Board discuss the topic in two parts - first to consider whether to hire counsel, and second to consider which firm to retain. Mr. Gearhart asked what firm counseled the district previously as he wanted to ensure the Board was not retaining counsel from that firm. He was assured they are not.

A motion was adopted to approve hiring separate counsel to review the Board's response to the Grand Jury, with a cap of \$5,000. Passed 6-0 (Gannon absent) with a motion by Mr. Chris Bausch and a second by Mrs. Dorian Baker.

A motion was adopted to retain (either Jeffery Minnery or Linda Summers Smith, both of Adamski Moroski Cumberland and Green LLP. Passed 6-0 (Gannon absent) with a motion by Mr. Christopher Arend and a second by Mr. Tim Gearhart.

**2. Grand Jury Report: Draft Response from the Board of Education**

Public comment was received from Berkley Baker, Peter Burne, Joel Peterson, and Joan Summers. The Board worked on specific language in its proposed response to the Grand Jury Report but did not complete this task.

**3. Grand Jury Report: Next Steps**

Public comment was received from Peter Burne. This item was tabled, to be addressed at the Adjourned Special Meeting to continue this agenda on February 2, 2021, at 4:00 p.m.

**4. Select Date and Time to Continue Work on Response to Grand Jury Report, If Necessary**
