### **DESCRIPTION OF SERVICES:**

MULTICULTURAL MUSIC AND DANCE IN PUBLIC SCHOOLS. This is a model project featuring 15 weekly sessions of 30-45\* minutes of multicultural music and dance for: Pre-K (2 classes), TK (1 class), Kindergarten (4 classes), Grade 1 (4 classes), and Grade 2 (3 classes).

The program includes performance(s) for all students at the end of their sessions as well as ongoing opportunities for informal and/or formal collaboration between Young Imaginations, the school and community outreach. Classroom teachers will attend classes with their students and complete an assessment at the end of the program as part of the requirements of the Marin Community Foundation/Buck Family Fund grant that partially funds the program.

Young Imaginations contract includes: 1) assignment of a lead arts educator and guest artists; 2) curriculum planning; 3) assessment of student learning; 4) informal and formal collaboration with school staff; 5) community outreach; 6) curriculum equipment/ materials for students' use in class. The agency provides liability insurance and maintains personnel records of arts educators.

[Note: Grade 2 classes are 45 minutes in length]

### **DATES OF SERVICES:**

15 weeks during the school year, Aug 18, 2016 – June 9, 2017, exact dates and times *tba*

### **AGREEMENT:**

In order to facilitate Young Imaginations' (YI) approach to creating a music and movement community between teachers and students, the SCHOOL agrees that teachers will be present with their students during YI's sessions in order to support the children's learning, and will collaborate, as appropriate.

It is understood between the parties to this agreement that Young Imaginations agrees to perform the services described above.
