**RESOLUTION OF THE BOARD OF EDUCATION OF
THE IRVINE UNIFIED SCHOOL DISTRICT
AUTHORIZING PLACEMENT OF A TEMPORARY MODULAR BUILDING FOR
MEASURE E OPERATIONS**

WHEREAS, the School District desires to place a temporary leased modular building on the property of the Jeffery Trail Middle School site located at 100 Visions, Irvine, CA 92620 for the intended use of office space for Bond Measure E Facilities and Construction operations; and

WHEREAS, the temporary leased modular building is defined as a structure that is not considered to be a “school building” and is not regulated by the Division of the State Architect (DSA); and

WHEREAS, the temporary leased modular building is designed and constructed in accordance with the requirements of the building code; and

WHEREAS, it shall be the responsibility of the School Board to take all necessary measures and precautions to prevent such use of the building to prevent injuries to pupils or teachers on school grounds as a result of a collapse. Such precautions may include fencing-off the non-school building from the rest of the school site and posting a sign stating that this building does not meet the earthquake safety requirements of the California State building code and shall not be entered by pupils or teachers; and

WHEREAS, California Code of Regulations (CCR) Section 4-310 of Title 24 requires a resolution be passed by the School Board stating the building or structure shall not be used for school purposes and that no pupils or teachers, as such, will be permitted to use or enter the said building for said purposes or be subject to a hazard resulting from its collapse. A copy of the resolution shall be submitted to DSA; and

WHEREAS, the Site Plan, Exhibit A, identifying the location of the temporary leased modular office is attached hereto directly following this Resolution;

NOW, THEREFORE, BE IT RESOLVED THAT

The temporary leased modular building shall not be used for school purposes and that no pupils or teachers, as such, will be permitted to use or enter the said building for said purposes or be subject to a hazard resulting from its collapse in compliance with California Code of Regulations (CCR) Section 4-310 of Title 24.
