**RESOLUTION TO DECREASE THE ELEMENTARY SCHOOL DISTRICT
NUMBER OF CERTIFICATED EMPLOYEES DUE TO A REDUCTION IN PARTICULAR KINDS OF SERVICES
FOR THE 2017-2018 SCHOOL YEAR**

WHEREAS, Education Code section 44955 permits the Governing Board to reduce or discontinue particular kinds of services not later than the beginning of the following school year; and

WHEREAS, the Governing Board of the San Rafael Elementary School District has determined that it shall be necessary to decrease the following programs and services of the District no later than the beginning of the **2017-2018** school year; and

WHEREAS, it shall be necessary to terminate at the end of the **2016-2017** school year the employment of certain certificated employees of the District as a result of the elimination of the programs and services; and

WHEREAS, the Governing Board of the San Rafael Elementary School District has further determined that among employees who first rendered paid service to the District on the same day, the order of termination will be based solely on the needs of the District and the students thereof;

THEREFORE, BE IT RESOLVED by the Governing Board of the San Rafael Elementary School District that the following particular kinds of services shall be reduced or eliminated no later than the beginning of the **2017-2018** school year:

Nothing herein shall be deemed to confer any status or rights upon temporary certificated employees or other employees in addition to those specifically granted to such employees by statute.
