





# The School Site Council

---

- The School Site Council (SSC) is an elected group representative of the school's staff, parents, and in secondary schools, students.
- The SSC works together to accomplish a set of tasks within the framework of the vision of the school system.



# How are SSC members chosen?


---

- All members, ***with the exception of the principal***, are elected by their peer group. The principal is assigned to serve as a permanent, voting member on the council. This responsibility may not be delegated.

# Membership Composition of an Elementary SSC

*California Education Code Section 52852 specifies:*


- The SSC shall ensure **parity** between

  - (b) parents or other community members elected by parents.





# FORM D: School Site Council Membership



# Responsibilities of the SSC

---

- Annually facilitate the revision/update of the school goals, improvement strategies and planned expenditures which are outlined in the *Single Plan for Student Achievement (SPSA)*.
- Ensure the school goals and improvement strategies are measurable and based on an analysis of verifiable state and local data.
- Ensure the goals, improvement strategies, and proposed expenditures are legally compliant and support the district's goals *and Local Control and Accountability Plan*.



# Responsibilities of the SSC, *continued*

---

- Seek input from all advisory committees.
- Approve and recommend the updated SPSA to the local governing board for approval.
- Monitor the implementation of the approved SPSA, making modifications as necessary.
- Measure the effectiveness of the improvement strategies and expenditures.
- Maintain documentation of all SSC actions and activities for three years.

## SPSA 2017-2018

---

- April/May 2017 = Preliminary amounts for the following school year were determined, site council reviewed and evaluated what programs to continue or eliminate.
- September/October 2017 = Sites receive finalized allocation amounts, new site council members are elected, and SPSAs are revised
