The purpose of this letter is to record an adjustment to the Basic Services fee on this project due to the award of the construction bid to Kya Services on August 10<sup>th</sup>, 2017. Our current Basic Services Fee for the Track & Field replacement work at Maria Carrillo High School is based on a construction cost estimate or budget of \$2,100,000. The bid was awarded at a cost of \$4,545,626.15, which, at the modernization fee schedule, generates a new Basic Services Fee of \$482,063.00, representing an increase to our Basic Services Fee of \$244,563.00. - 10,000 = 234,563<sup>00</sup>

However, at the request of Mike Braff and in consideration of excellent working relationship that we have with Santa Rosa City Schools, we will reduce our fee by \$10,000 for a total of \$472,063.00. Per the Owner Architect agreement for this project dated January 11, 2017, we will adjust our fee to reflect the increased Basic Services Fee on our billing cycle this month.
