School Facility Conditions and Planned Improvements (Most Recent Year)

Cleaning Process: Coleman F. Brown Elementary School strives to maintain a safe, healthy, nurturing and orderly school campus that encourages positive attitudes in students and staff. The district governing board has adopted cleaning standards for all schools in the district. Schools are on a regular cleaning schedule including wiping surface areas, being swept or vacuumed and the trash emptied. The cafeteria, gym, and all restrooms are cleaned daily. Grounds are groomed on a rotating basis with trash, lawn, and plumbing issues addressed as needed. All classrooms, restrooms and common areas are clean and ready for learning on a daily basis. The maintenance department will continue forward with preventative maintenance and routine repair and maintenance throughout the year.

Maintenance and Repair: The District maintenance staff ensures that repairs necessary to keep each school in good repair and working order are completed in a timely manner. Four full-time maintenance staff ensure that all classrooms and facilities are in adequate condition. Over the summer of 2016, at Coleman F. Brown Elementary, 2 projects took place. The roof on the MPR was replaced and the VCT was removed from the MPR floor and the concrete was polished.

Upcoming repairs needed involve replacing some duct work in the 10's pod. This project has already gone to bid and has been awarded. Looking to schedule the work soon. All exterior lighting has been retrofitted.

School Safety Plan (School Year 2016-17)

Coleman F. Brown Elementary School has adopted a comprehensive School Safety Plan that is reviewed and updated annually by members of the School Site Council. The Site Council is comprised of teachers, classified staff, parents, and the principal. The Safety Plan for the 2015-2016 school year was formally approved by the school's School Site Council on 2/18/2016. The school staff suggested final changes and had input on new assignments at the 8/10/2015 staff meeting. The revised Safety Plans are presented to the Sylvan Union School District Board of Trustees for annual review and approval. The Safety Plan is reviewed with staff members at the beginning of each school year with particular attention paid to emergency situations and staff and student responses. Safety drills, including fire, earthquake, and lock-down procedures, are held regularly. In addition, the school is inspected annually by the fire marshal and daily by the custodian. All issues discovered during these inspections are given the utmost priority. Copies of the comprehensive School Safety Plan are posted in each classroom and office area.
