#### School Facility Conditions and Planned Improvements (Most Recent Year)

**Cleaning Process:** Somerset Middle School strives to maintain a safe, healthy, nurturing and orderly school campus that encourages positive attitudes in students and staff. The district governing board has adopted cleaning standards for all schools in the district. Schools are on a regular cleaning schedule including wiping surface areas, being swept or vacuumed and the trash emptied. The cafeteria, gym, and all restrooms are cleaned daily. Grounds are groomed on a rotating basis with trash, lawn, and plumbing issues addressed as needed.

**Maintenance and Repair:** The District maintenance staff ensures that repairs necessary to keep each school in good repair and working order are completed in a timely manner. Four full-time maintenance staff ensure that all classrooms and facilities are in adequate condition. A work order process is used to ensure efficient service; emergency repairs are given the highest priority. At the time of publication, 100% of campus restrooms are in complete working order. The results of our inspections are the result of a continuous inspection thorough the year. Somerset's intercom system will be upgraded, the MPR's facade will be repaired due to bird damage. A gas leak was found and is being repaired. 20 HVAC units were replaced; also all the conduit between HVAC units on the roof was replaced. The interior and exterior lighting was retrofitted. The bus drive at Rumble was widened and an electric gate was installed. There will be ongoing maintenance as issues arise throughout the year.

### School Safety Plan (School Year 2016-17)

Somerset Middle School has adopted a comprehensive School Safety Plan that is reviewed and updated annually by members of the School Site Council. The Site Council is comprised of teachers, classified staff, parents, and the principal. The Safety Plan for the 2015-2016 school year was formally approved by the school's School Site Council on 2/24/2016. The school staff suggested final changes and had input on new assignments at the 2/1/2016 staff meeting. The revised Safety Plans are presented to the Sylvan Union School District Board of Trustees for annual review and approval. The Safety Plan is reviewed with staff members at the beginning of each school year with particular attention paid to emergency situations and staff and student responses. Safety drills, including fire, earthquake, and lockdown procedures, are held regularly. In addition, the school is inspected annually by the fire marshal and daily by the custodian. All issues discovered during these inspections are given the utmost priority. Copies of the comprehensive School Safety Plan are posted in each classroom and office area.
