RESOLUTION #2017-30

SALE OF FOOD SERVICE TRUCK TO THE SYLVAN UNION SCHOOL DISTRICT

WHEREAS, the Stanislaus County Board of Education ("SCBOE") maintains a number of county community schools and as such is "deemed to be a school district" by Education Code section 1984; and,

WHEREAS, the Stanislaus County Superintendent of Schools used to contract with the Salida Union School District for food services at the county community school sites, but this contract expired at the end of the 2017-2018 school year and the Salida Union School District was no longer able to provide this service, so SCBOE, through the Stanislaus County Superintendent of Schools, has entered into an agreement for food services with the Sylvan Union School District ("District") whereby the District is working cooperatively with the SCBOE, pursuant to the terms of the negotiated agreement, to assist in providing food services to the county community school sites; and,

WHEREAS, the Stanislaus County Superintendent of Schools is in the process of purchasing a new food service delivery truck for SCBOE that will be used by SCBOE to deliver food to its community school sites and by District to deliver food to District school sites and will also be used by the District to deliver food to District owned school sites; and,

WHEREAS, the food services agreement between the Stanislaus County Superintendent of Schools and the District provides that the Stanislaus County Superintendent of Schools to purchase a new food delivery truck and subsequently sell this new food delivery truck at cost to the District; and,

WHEREAS, the truck is a 2017 Chevrolet 4500XD Diesel (CT 42003) 2WD Regular Cab 132.5" truck that is currently on order from American Chevrolet of Modesto for the price of \$85,387.85 as noted in Exhibit A attached to this Resolution; and,

WHEREAS, section 17540 of the California Education Code authorizes the governing board of a school district to sell any personal property belonging to the district to any other school district and the governing board of the purchasing school district may purchase the property for an amount equal to the cost of purchase without advertisement for or receipt of bids or compliance with any other provisions of the Education Code.

NOW, THEREFORE BE IT RESOLVED, that SCBOE hereby agrees to sell to the District the above referenced new food delivery truck, as identified in Exhibit A, for the "cost" price of \$85,387.85 contingent upon the approval of this sale by the Sylvan Union School District Board of Trustees, and

BE IT FURTHER RESOLVED, that the Stanislaus County Superintendent of Schools or his designee is directed, to deliver said truck to the District as soon as this truck is delivered to the Stanislaus County Superintendent of Schools pursuant to the existing purchase agreement with Champion Chevrolet.

THE FOREGOING RESOLUTION was introduced at a regular meeting of the STANISLAUS COUNTY BOARD OF EDUCATION held on the 12th day of September, 2017, by Board of Education Member K. Rose, who made the motion, which motion being duly seconded by A. Pollard, was upon roll call, carried into Resolution and passed by the following vote:
