#### School Description and Mission Statement (School Year 2017-18)

Orchard Elementary School opened its doors to educating children in grades Kindergarten through fifth grade in 1994. During the 2016-2017 school year, approximately 585 students were enrolled in kindergarten through fifth grade. ## School Facility Conditions and Planned Improvements (Most Recent Year)

**Cleaning Process:** Orchard Elementary School strives to maintain a safe, healthy, nurturing and orderly school campus that encourages positive attitudes in students and staff. The district governing board has adopted cleaning standards for all schools in the district. Schools are on a regular cleaning schedule including wiping surface areas, being swept or vacuumed and the trash emptied. The cafeteria, gym, and all restrooms are cleaned daily. Grounds are groomed on a rotating basis with trash, lawn, and plumbing issues addressed as needed.

**Maintenance and Repair:** The District maintenance staff ensures that repairs necessary to keep each school in good repair and working order are completed in a timely manner. Four full-time maintenance staff ensure that all classrooms and facilities are in adequate condition. A work order process is used to ensure efficient service; emergency repairs are given the highest priority. At the time of publication, 100% of campus restrooms are in complete working order. **Repairs Needed:** The biggest concern at Orchard is the HVAC system. The boiler and chiller are aging and rapidly deteriorating. In July, compressor #2 failed and needed to be replaced. It was replaced in the last week of July and then it failed again the week of August 16th. The compressor was replaced for a second time. At one point the system was operating at 50% capacity with full classrooms. The school needs to be painted as well. **Corrective Actions:** In knowing that Orchard's HVAC system is in need of replacement, the project was approved and went out to public bid. Not only will this encompass the HVAC system being replaced with package units but some other work will be done as well. The site will receive new carpet, paint (interior and exterior) and some cabinetry will be added. Orchard is set to receive a much needed overhaul on some of its major systems. For its age, Orchard Elementary School is in good repair. The maintenance department will continue to provide preventative maintenance and routine repair and maintenance throughout the year.

### School Safety Plan (School Year 2017-18)

Orchard Elementary School has adopted a comprehensive School Safety Plan that is reviewed and updated annually by members of the School Site Council. The Site Council is comprised of teachers, classified staff, parents, and the principal. The Safety Plan for the 2016-2017 school year was formally approved by the school's School Site Council on 2/28/2017. The school staff suggested final changes and had input on new assignments at the 8/15/2016 staff meeting. The revised Safety Plans are presented to the Sylvan Union School District Board of Trustees for annual review and approval. The Safety Plan is reviewed with staff members at the beginning of each school year with particular attention paid to emergency situations and staff and student responses. Safety drills, including fire, earthquake, and lockdown procedures, are held regularly. In addition, the school is inspected annually by the fire marshal and daily by the custodian. All issues discovered during these inspections are given the utmost priority. Copies of the comprehensive School Safety Plan are posted in each classroom and office area.
