School Facility Conditions and Planned Improvements (Most Recent Year)

Cleaning Process: Elizabeth Ustach Middle School strives to maintain a safe, healthy, nurturing and orderly school campus that encourages positive attitudes in students and staff. The district governing board has adopted cleaning standards for all schools in the district. Schools are on a regular cleaning schedule including wiping surface areas, being swept or vacuumed and the trash emptied. The cafeteria, gym, and all restrooms are cleaned daily. Grounds are groomed on a rotating basis with trash, lawn, and plumbing issues addressed as needed.

Maintenance and Repair: The District maintenance staff ensures that repairs necessary to keep each school in good repair and working order are completed in a timely manner. Four full-time maintenance staff ensure that all classrooms and facilities are in adequate condition. A work order process is used to ensure efficient service; emergency repairs are given the highest priority. The results of our inspections are the result of a continuous inspection thorough the year. Although aging, Ustach Middle School is in good repair. Much of the school and it's systems are showing signs of being 22+ years old but all is operational. All of the asphalt on site is in need of being sealed. At the end of June we located a significant leak to the domestic water supply on the interior of the campus. The AC unit for the main area of the MPR has aged to the point of replacement . There were 8 portables that were refurbished inside and out over the summer. All parking lot and playground areas were re-sealed and striped by Womack Striping at the end of July. Nicro Mechanical was on site for the month of July making the needed repairs to the domestic water supply and replacing the concrete that was removed. Overhaul Construction did the refurbishing of the portables.

The sylvan maintenance department has ordered and received the new 25 ton AC unit for the replacement at the MPR and it is scheduled for the winter break. Ustach is up to have the chiller system removed and all new package units installed. This could transpire within the next year or two. Ustach Middle School is in good repair and is ready for daily learning activities.

School Safety Plan (School Year 2017-18)

Elizabeth Ustach Middle School has adopted a comprehensive School Safety Plan that is reviewed and updated annually by members of the School Site Council. The Site Council is comprised of teachers, classified staff, parents, and the principal. The Safety Plan for the 2016-2017 school year was formally approved by the school's School Site Council on 2/8/2017. The school staff suggested final changes and had input on new assignments at the 8/9/2016 staff meeting. The revised Safety Plans are presented to the Sylvan Union School District Board of Trustees for annual review and approval. The Safety Plan is reviewed with staff members at the beginning of each school year with particular attention paid to emergency situations and staff and student responses. Safety drills, including fire, earthquake, and lockdown procedures, are held regularly. In addition, the school is inspected annually by the fire marshal and daily by the custodian. All issues discovered during these inspections are given the utmost priority. Copies of the comprehensive School Safety Plan are posted in each classroom and office area.
