Scope of Work

- ➤ Utilize video conferencing for initial meetings with the District Planning Team and then the School Principals in winter or spring 2018 to discuss the Agnews boundary change processes, timelines, Boundary Advisory Committee composition, criteria for boundary changes, and relevant school district policies and practices, and other information.
- Provide slide presentations for all meetings that will include enrollment projections, new residential research, boundary scenarios with geographic area projections, and other relevant data, information and map graphics.
- Chair five meetings convened at a school site or the district office with a school district Agnews Boundary Advisory Committee (ABAC) to present school enrollment projections and other school and district data, review, refine, and reconfigure school boundaries for the anticipated opening of a new elementary, middle and high school in the northern portion of the Santa Clara Unified School District.
- Utilize video conferencing for a meeting with the District Planning Team (DPT) before the ABAC meetings, Board Study Session, Community Forums, and Board Meeting to consult with DPT members over the continued process, development of new boundaries, and final recommendation for a boundary change to the Board of Education.
- ➤ Provide follow up support to the Santa Clara Unified School District for implementation of the new boundaries, including, new Custom Layer Boundaries, MySchoolLocator, and student mailing lists. High Resolution 11x17 and 36"x24" digital maps for the approved and final new boundaries are available upon request at an additional cost through DecisionInsite.

Fee Breakdown
