Kathleen Hall said she wants to publicly thank Superintendent Williams for all that he has done in regards to this student event, and in dealing with the adverse publicity, all of the phone calls, and emails.

Matt McClish said that it has been a tough situation dealing with tomorrow's event, but he feels like the District is handling it well and he is looking forward to it. He attended a Bearcat Dreamers Conference, a Special Olympics competition at the high school, Read Across America Day at Peterson Elementary, and a recognition event for Crimson Newsmagazine.
