The LCAP is the plan for continuous improvement based on student need, data and stakeholder engagement.





LCAP- District Plan

- Addresses the **instructional needs** of all students
- Requires **special attention** be paid to the specific needs of students who are low income, foster youth, or English learners
- We address groups of students who are in the red indicator or two or more levels below all students
 - **English Language Arts-** Students who are; English Learners, socioeconomically disadvantaged, homeless, Hispanic, Pacific Islander and students with disabilities
 - **Math-** Students who are English Learners, socioeconomically disadvantaged, homeless, African American, Hispanic, Pacific Islander, homeless and students with disabilities
