Based on the 2016-2017 number of identified migrant students in your district and the information we have at this time, a preliminary allocation of **\$265,957** for regular funds and **\$16,080** for school readiness, a combined total of **\$282,037** has been determined for 2018-2019 services to migrant students in your district. School readiness funds must only be used for preschoolers.

As of April 4, 2018, the student count in your district is **313**, which will be used for planning purposes.


