The District's summary appeal was unsuccessful, but a secondary appeal option has commenced.

#### Minutes:

Superintendent David Jones recognized 2017-18 Student Board Member Shawn Mackenzie-Heck for his service. He praised the "impressive, exciting, fun and emotional" first-ever commencement ceremony for Bonsall High School, congratulating the administration, students and staff for a job well done. Mr. Jones shared some highlights from the end-of-year celebrations he was able to attend. As the first school year at BUSD draws to a close, Mr. Jones thanked the board members and President Coen for the incredible amount of support throughout the year, along with Gina McInerny for help integrating into the Bonsall schools community. He thanked the principals and directors for the positive relationships being developed, and that he looks forward to continuing the collaboration into the next year school year. Mr. Jones advised the Board that the Leadership team is currently doing a book study and will attend a training in the fall in Long Beach as the focus on improving student learning intensifies. Mr. Jones also advised that he held the third Community Collaborative Discussion on June 12 where he reviewed factual information regarding the bond resolution. Architect Richard Nowicki attended the meeting and presented the schematic design drawings (June 2017) and an overview of the design development phase.

He regards the BHS graduation as the culmination, and a celebration, of a lot of hard work by many people. While serving on the Board, Mr. Ortega hopes to bring more Native American local culture awareness to the schools. Last week he attended a conference at Pala hosted by CSUSM and SDCOE focused on teaching local Native American history to teachers. The training will occur again next year, with registration and sub-costs paid for by a grant. He hopes the Board will support sending as many teachers as prudent to this training.

Member Tucker: Wished everyone a happy summer.

Member Olson: Wished Member Tucker a happy 97th birthday and everyone a long and happy summer.

President Coen: Echoed the birthday wishes to Member Tucker. Congratulated Student Member Mackenzie-Heck on all of his impressive accomplishments, including being a great board member. Thanked Member Ortega for his efforts to bring more access to Native American culture into the district. Dr. Coen recalled that when he first ran for the Board (at least 14 years ago), he had two goals 1) modernize Bonsall Elementary; and, 2) establish a high school.
