5. BOARD STUDY SESSION - 9:05 a.m.

5.a. Overview: Educational Facility Master Plan - 9:05 a.m.

Superintendent Jim Hogeboom provided an overview of the District's Educational Facility Master Plan and process.

5.b. Conceptual Site Plans and Budgeted Project Costs - 9:15 a.m.

Karen Maloney, Assistant Superintendent, Business & Operations, introduced Steve Hospodar, Hamilton K-8 Principal and Elizabeth Olinyk, Olive Elementary School Principal, to report on their educational plan that is driving the changes to their facilities.

President Knell announced a return to Item "5.a." - Overview: Educational Facility Master Plan.

Karen Maloney, Assistant Superintendent, Business & Operations, reported that the most recent version of the educational plan that is driving the changes to facilities for each school site would be presented by a principal or site representative from Lynwood, San Jose, Sinaloa, San Marin and Novato High School. An overview of Tier I (Basic Upgrades / Code), Tier II (District Priorities), and Tier III (Site-Specific Priorities) was presented.

Kevin MacQuarrie of WLC Architects answered clarifying questions.

Seven (7) people, including staff and parents, commented on the conceptual site plans.

5.c. General Obligation (G.O.) Bond Timeline and Update - 10:30 a.m.

Charles Heath, Partner, TBWB Strategies, shared a PowerPoint presentation on the

G.O. Bond timeline, polling results, and overall voter support of a bond priced at different rates.

5.d. Review Form of Ballot Measure Resolution - 10:45 a.m.

Janet Mueller, Attorney, DWK, reported on the sample form of the ballot measure resolution, and the District's resolution for calling a Bond election in November.

6. DISCUSSION/ACTION - 11:15 a.m.

6.a. Approve Bond Tax Rate - 11:15 a.m.

Karen Maloney, Assistant Superintendent, Business & Operations, reported on the selling of General Obligation Bonds by California School Districts is a common way that school districts generate capital funds for use in the repair, improvement, modernization, and building of school facilities along with the purchase of furnishings, equipment, and technology. Proposition 39, Education Code 15000 and Governing Code Section 53506 provide the guidance for the issuance of debt. Proposition 39 provides that the tax rate, as the result of any single election, must be projected to be no more than \$60 per \$100,000 of Assessed Valuation (AV) per year for Unified School Districts. However, a school district can choose to set a rate of less than \$60 per \$100,000 of AV.

The Project List was developed based on projected proceeds from bond sales in the amount of \$222 million.

Public Comment:

A community member commented on having bond monies be used for repair of a facility in case of a natural disaster or the health and safety of the students.

Motion Passed: A motion to approve the bond tax rate of not more than \$60 per \$100,000 Assessed Valuation passed by a vote of 7-0. Passed with a motion by Mr. Ross Millerick and a second by Mr. Gregory Mack.

Karen Maloney, Assistant Superintendent, Business & Operations reported that Resolution 19-2015/2016 provides that the District will issue debt utilizing the Competitive Sale method, unless there is a persuasive reason to utilize the Negotiated Sale method.

6.c. Authorization to Begin Public Bidding for the Lease and Installation of Portable Buildings at Lu Sutton and Olive Elementary and Novato High School - 11:45 a.m.

Trustee Mack left the meeting for a prior engagement.

Karen Maloney, Assistant Superintendent, Business & Operations, and Adam Coll, Construction Manager, Greystone West, reported that in Spring 2016, the District received notification from the California Department of Education (CDE) that grant funding would be awarded for four new preschool locations within the District. The preschools will be located at Hamilton School and Loma Verde, Lynwood and Olive Elementary schools. Loma Verde and Hamilton have classroom space available and the ability to have the spaces licensed for preschool use, as required by the CDE. Olive and Lynwood do not have any appropriate classroom space available for a preschool program. As such, each site requires a portable classroom with bathrooms in order to operate a preschool program beginning Fall 2016.

Enrollment growth is projected for Novato High School (NHS); therefore, it is necessary to have additional classroom space to accommodate this growth.

Public Comment:

A NUSD employee commented that adding more buildings also means additional personnel to maintain them.

Karen Maloney, Assistant Superintendent, Business and Operations, stated the formula for custodian use will be updated and reviewed which is based on square footage of facilities.

Motion Passed: A motion to approve the Authorization to Begin Public Bidding for the Lease and Installation of Portable Buildings at Lu Sutton and Olive Elementary and Novato High School passed by a vote of 6-0, 1.
