### 13. DISCUSSION/ACTION - 8:10 p.m.

#### 13.a. NUSD Graduate Profile - 8:10 p.m.

Jim Hogeboom, Superintendent, reported on the NUSD Graduate Profile. In September 2015, The Novato Unified School District Board of Trustees directed Superintendent Hogeboom to work with all stakeholders to identify key student outcomes expected of all high school students upon graduation. These outcomes would provide the foundation for the Novato Unified School District's Graduate Profile. This mandate led to the formation of the District Advisory Committee (DAC), which is comprised of a wide variety of district stakeholders such as parents, students, teachers, administrators, classified staff, DELAC/ELAC parents, and community partners and members. They worked together over several months to answer the question: What skills do our students need to have to be successful in the 21st Century? The DAC identified six skills that NUSD students should develop and master during their time in our schools. These skills are referred to as the six C's: Collaboration, Communication, Critical Thinking, Conscientious Learner, Cultural Competence and Character. This work resulted in a document that is referred to as the NUSD "Graduate Profile". The Graduate profile clearly identifies the most important knowledge and skills that all NUSD students must have upon graduation.

The District Leadership Team (DLT), comprised mostly of teachers and administrators from each school, will strive to answer the question: How do we ensure that these skills are taught, assessed and mastered? The DLT is taking the 6 C's work that was developed by the District Advisory Committee and is working to identify essential supports that must be in place to ensure that all students are provided with the necessary guidance and resources to be college and career ready, including more opportunities for personalization. The goal of the DLT is to involve teachers and administrators in the implementation of the NUSD Graduate Profile and answer our driving question, "How do we use our graduate profile to transform teaching and learning in the Novato Unified School District?" The DLT will serve as an advisory committee to plan out professional development needs related to the Graduate Profile, and to focus on developing a Performance Assessment System along with the use of Project Based Learning (PBL) as a key structure to support the development of the 6 C's.

### **13.b. Approval of Full-time Athletic Director and Job Description - 8:30 p.m.**

Kris Cosca, Assistant Superintendent of Human Resources, reported on the Athletic Task Force's recommendation for full-time Athletic Directors at each comprehensive high school along with an updated job description for the Athletic Directors. The Task Force sought input from students, parents, coaches and school administrators as to how NUSD can strengthen and enhance every aspect of its sports programs. Topics considered were the role of the athletic director, coaching (recruitment, training, development), parent involvement, facilities, sportsmanship at games, youth development, middle school sports, character development and transportation. The Task Force's number one recommendation was to increase the staffing allocation for Athletic Director from .4 FTE to 1.0 at each comprehensive high school. It is the Task Force's belief that this step will help Novato Unified School District to provide a high quality athletic experience to support NUSD student athletes in the two comprehensive district high schools.

### **13.c. Approve the Agreement with Rincon Consultants, Inc. for Required CEQA Reporting in Conjunction with the Proposed Stadium Lights at San Marin High School - 8:40 p.m.**

Karen Maloney, Assistant Superintendent, Business & Operations, and Adam Coll, Construction Manager, Greystone West, reported on April 5, 2016, the Board of Trustees approved District staff to conduct a Request For Proposal (RFP) process to find the best qualified CEQA consultant to provide an Environmental Impact Report for the possible installation of stadium lights and new sound system at the San Marin High School Stadium Field.

On April 29, 2016, five (5) proposals were received. District Administration and Greystone West reviewed the five proposals and concluded that all five firms were qualified. On May 6, 2016, a committee of eight interviewed four firms Dudek, Grasseti Environmental, Rincon and WRA. The Committee selected Rincon Consultants, Inc. as the most qualified firm and their agreement has been reviewed by District legal. Mark Kelley, Attorney, DWK, was present to answer any legal questions.

### **13.d. Approve Renewal of Novato Charter School K-8 Charter And Related Agreements - 8:55 p.m.**

Karen Maloney, Assistant Superintendent, Business & Operations, reported the Novato Charter School (NCS) K-8 Charter Renewal Petition, including action on the Fifth Amended Memorandum of Understanding (MOU) and Lease/Facilities Use Agreement.

Education Code section 47607 permits a chartering school district to grant the renewal of a charter school petition for a term of five years. Charter renewals are governed by the same standards and criteria as initial charter school petitions. Novato Unified School District (NUSD) staff has been meeting with NCS representatives since October 2015 to discuss terms and conditions for another charter term, including terms and conditions for a new MOU and Lease/Facilities Use Agreement at Hamilton.

The required Public Hearing for the Charter Petition was held at the May 3, 2016 NUSD's Regular Board meeting. Comments and questions could not be considered at that time, so the Charter Petition was included on the May 17, 2016 agenda for discussion and approval. The Charter Petition was reviewed by an outside consulting group, Ryland School Business Consulting, and legal counsel, Janet Mueller of DWK. With the renewal of the Charter for another term, the Board of Trustees will concurrently enter into a revised MOU and Lease/Facilities Use Agreement.

Comments received from the public and expressed by the Board of Trustees focused on increasing student diversity to more closely match the demographics of NUSD. Over the past five years, NCS has worked to achieve a racial and ethnic balance among its students that is reflective of Novato's resident population (Ed Code 47605(b)(5)(G)).

In a continuing effort to facilitate access to the school and its alternative program, NCS will change the following practices and policies:

1. Starting in 2016-2017, school tours will no longer be mandatory for parents to who want to apply for participation in the enrollment lottery.
2. Starting in 2016-2017, the Hispanic Outreach Committee will reach out to community preschools and pediatric clinics, e.g. North Bay Children's Center, Hamilton Community Center Preschool, to conduct Spanish-language school tours at their sites.

3. Starting in 2017-2018, NCS will no longer give enrollment preference to previous-year applicants on the wait list.

District legal counsel, Janet Mueller of DWK, reviewed the Charter Petition and the MOU. The consulting firm, Ryland School Business Consulting, performed a review of the Charter Renewal Petition, the NCS Independent financial audit for year ended June 30, 2015, and the MOU. The report confirmed issues and concerns noted by the NUSD Business Department which were the result of lack of attention to detail in preparation of reports. NUSD Business staff will meet with the new NCS Chief Business Official to emphasize the need for accurate reports.

Ryland School Business Consulting also suggested monitoring Special Education staffing and services provided to NCS, and NUSD will continue to monitor services provided in relationship to fees charged.

Public Comment:

A parent commented on the renewal of the Novato Charter School K-8 Charter and related agreements.

Trustee Aguila made a motion to approve the renewal of Novato Charter School K-8 Charter and related agreements. Trustee Cooper made a motion to amend the motion to include the MOU with NUSD and the Novato Charter School to be reviewed annually.

Karen Maloney, Assistant Superintendent, Business and Operations, suggested the Board of Trustees give direction to staff on guidelines and goals for the Novato Charter School. Trustees agreed to give staff direction on developing clear guidelines for Novato Charter School.

Trustee Cooper withdrew his motion to amend the motion that the MOU with NUSD and the Novato Charter School be reviewed annually.

**13.e. Educator Effectiveness Funds Plan Implementation & Professional Development Plan for Project-Based Learning - 9:15 p.m.**

Julia Kempkey, Director of Curriculum & Instruction, reported on September 22, 2015 Governor Brown signed SB103, the Education Trailer Bill, into law, which contained revised appropriation language for the \$490 million to be disbursed to local educational agencies for purposes of enhancing the effectiveness of



teachers and administrators. These Educator Effectiveness funds may be used to support the professional development of certificated teachers, administrators and paraprofessional educators. This new funding is provided specifically to support these activities:

- Beginning teacher and administrator support and mentoring, including, but not limited to, programs that support new teacher and administrator ability to teach or lead effectively and meet induction requirements.
- Professional Development, coaching, and support services for teachers who have been identified as needing improvement or additional support by local educational agencies.
- Professional development for teachers and administrators, aligned to the state content standards.
- To promote educator quality and effectiveness, including, but not limited to, training on mentoring and coaching certificated staff and training certificated staff to support effective teaching and learning.

The funds must be spent by July 1, 2018. As a condition of receiving the funds, a spending plan for the funds must be presented at a public meeting of the governing board and then approved at a subsequent public meeting of the Board of Trustees. The California Department of Education has provided Novato Unified School District one-time funds of \$644,559 for educator effectiveness. The draft plan for Educator Effectiveness Funds for Novato Unified School District was presented to the District Leadership Team and Administrators who reviewed and provided feedback. From this input and from any comments from the public hearing, the final draft was developed and was recommended for Board of Trustee approval.

### **13.f. Approval of New Course Outlines and Technical Revision to Existing Course Outline - 9:25 p.m.**

Megan Pettis, Coordinator Secondary Curriculum & Instruction, reported on the new course outlines: AP Calculus BC, AP Comparative Government, AP Computer Science, Applied Chemistry and Biotechnology, Contemporary Global Issues, Robotics, Senior Engineering STEM, The Physics of Making Things, The Technology of Biology and ELD Summer Intensive Course, and technical revisions to the following existing course outlines: Personal Finance, AP Physics, GA Environmental Engineering, GA Environmental Science, GIS Fundamentals, Introduction to Networking and IT Essentials. In an effort to ensure that the Novato

Unified School District offers current and relevant courses for its high school programs, staff have developed six new course outlines to be offered starting in the fall of 2016. The course outlines were developed by teachers and reviewed by teachers from across the district. Courses seeking UC a-g approval have been submitted to UC for review. The technical revisions are intended to better align course subject and pre-requisite information with the course content.

### **13.g. First Reading: Board Policy 6152.1 Placement in Mathematics Courses - 9:35 p.m.**

Julia Kempkey, Director of Curriculum & Instruction, reported that Senate Bill 359 (Chapter 508, Statutes of 2015), known as the California Mathematics Placement Act of 2015, was signed by Governor Jerry Brown on October 5, 2015, and took effect on January 1, 2016. This bill emphasizes the importance of providing students with access to mathematics courses that prepare students for college and career. Further, it is the intent of the bill that all students should have the opportunity to excel in mathematics. The California Mathematics Placement Act of 2015 requires the governing boards or bodies of local educational agencies (LEAs) that serve pupils entering grade nine adopt "a fair, objective, and transparent mathematics placement policy" before the beginning of the 2016-17 school year if it has not already been done. The mathematics placement policy for students entering grade nine must meet the following requirements:

- Systematically takes multiple objective academic measures of student performance into consideration
- Includes at least one placement checkpoint within the first month of the school year to ensure accurate placement and to permit reevaluation of individual student progress
- Requires an annual examination of student placement data to ensure that students are not held back in a disproportionate manner on the basis of their race, ethnicity, gender, or socioeconomic background
- Requires a report on the results of the annual examination by the local educational agency to its governing board or body
- Offers clear and timely recourse for each student and his or her parent or legal guardian who questions the student's placement

The proposed new NUSD Board Policy 6152.1 included all of the required components and followed the California School Board Association's recommended language.
