Summer Migrant Education Student Trip to Washington

Beth Kirkley, EL/Migrant Education Director, introduced students Alex Santiago and Jose Lopez, who reported on the US history program summer trip to Washington, DC. Alex gave a presentation about what he learned while on the trip and his experience with the Vietnam Memorial. The students thanked the Migrant Education Program for the opportunity to attend the trip along with 48 students from other districts.

UTA Report

Terry d'Selkie, UTA President, reported that a UTA Rep Council meeting was held, thanked the Board for negotiations and for the 54%

which will provide staff with a nice raise; shared aluminum water bottles, asked district to continue to look at ways we can reduce the carbon footprint.

Leadership Team Report

Kris Swett, South Valley High School (SVHS) Principal, reported on the CA Principals' Support Network that Leadership is involved in, noting that he and Frank Zeek Principal Dara Brown are in year 3 of the network, whereas all other principals are in year 2. He stated that from his perspective we are seeing huge changes, like what Frank Zeek is doing with their PLC process; he and Dara have been trained heavily in this as a result of the CA Principals' Support Network and it is making a difference.

He also reported about SVHS and Big Picture Ukiah. He thanked the Board and District for their support and stressed how important community connections are for them.

- Family engagement is great and getting even better at SVHS. Parents must attend student exhibitions and presentations. Kris pointed out that culture is a key to success at SVHS and they have a variety of cultural activities; for example, all students have community service weekly.
- Last year there were 25 internships, this year there are approximately 40 so far. If anyone knows about a local business, organization, or individual in need of an intern, please contact SVHS.
- SVHS has approximately 120 students. 82 students graduated last year. They had 0 expulsions and 12 suspensions last year. (33 suspensions 3 years ago)

UUSD School Facilities: Challenges and Opportunities

Penny Lauseng, CBO, presented an update on school facilities. In November 2017, the Board of Education approved the UUSD Facilities Master Plan (FMP) which was developed through a series of committee meetings with a variety of stakeholders in the community. The information presented was both a review of the Facilities Master Plan as it pertains to the overall facility needs of the district and the possible funding options available to fund the facility projects identified in the FMP.

Penny reviewed the challenges we face: most schools were built many years ago and all show signs of aging; school facilities require upgrades to support 21st century learning; aging classrooms and other

instructional facilities need repairs; school safety improvements, including fencing, are necessary to support continued quality education. A review of each site's needs was presented. Gabe Sherman, MOT Director, pointed out that the estimated costs are based on the 2017 figures that are not including cost escalation, which on an average is 10% per year.

In addition to the maintenance, building code and transformational facility needs identified in the FMP, the Superintendent, through an ad hoc committee, has explored and recommends a high priority be placed on the need to build an all weather artificial turf field at Ukiah High School for the benefit of students and the community. All weather fields, have been a concern at almost every campus.

Shane Huff, UHS PE Instructor, spoke about the need for all weather fields, described the challenges PE teachers and student classes have, that a facility with an all weather field will allow for the classroom physical perspective, and from the athletic perspective we have facilities that don't match our athletic students' needs, especially in the winter with sports such as soccer. He described the NCAA standards for soccer fields that our current playing surfaces do not meet the needs; feels it is important to recognize the need for our PE students, our student athletics and our community needs. He spoke of the soccer club programs that come to our community, they stay in hotels, shop in our stores, and bringing tax dollars to community.

Penny recounted that the turf committee was formed to explore solutions and recommendations, including costs of artificial turf field. They looked at the impact to Students/Athletes – fields are outdoor classrooms to 1,200 students/day, and an ability to offer year round healthy, outdoor activities. The committee determined a high priority need to build an artificial turf field at Ukiah High School.

Penny reviewed the potential state funding match, and a local match and local resources needed. UUSD would be eligible for approximately \$20 million in state funding match: Relocatables: \$10,250,000 • Permanent: \$9,350,000

This assumes a local match of approximately \$13 million: Relocatables: \$6,800,000 • Permanent: \$6,300,000

The UUSD Board is considering placing a measure on the March 3, 2020 ballot to fund school facilities upgrades. A proposed measure would extend the current tax rate to no more than \$60 per \$100,000 in assessed home value (not market value). The measure would generate up to \$88 million in locally controlled funding. All funding would stay local to support Ukiah Unified schools and could never be taken away by the State. No funds could be used for administrators' salaries or pensions. A Citizens' Oversight Committee and independent audits would be required to ensure all funds are spent as required

by law.

Penny noted that this is an information item and that no motion is needed. The powerpoint is attached and hereby made a part of these minutes.

South Valley High School Site
Improvements Review and
Recommendation Including Additional
Classroom and Food Service Area

Gabe Sherman, MOT Director, presented the analysis and recommendation for the South Valley High School campus site improvements. He provided a review of the administration building and site improvements project that was completed during the summer of 2018.

Gabe reported that with a shift to the Big Picture model of instruction, a food services oriented CTE classroom is no longer a high priority for the school. A reprioritization of the schools needs provides an opportunity for several critical site improvements that are achievable within the current budget of approximately \$1.5 million.

- Removal of the old administration building
- A dedicated food service building and indoor eating area
- Covered outdoor common space
- Additional convertible instructional/office housing. The food service building and additional instructional space could be provided by standardized 960 sq/ft modular buildings with some customization; alternate option is stick built. The use of modular buildings will allow for flexibility in design, construction and would accommodate a more timely installation within the identified budget.

Trustees held discussions regarding an appropriate food service area for students and inquired whether or not a shade structure is included in the budget. Gabe reported that he has not done a cost estimation; he is asking to pursue the item.

Motion by Trustee Van Sant, seconded by Trustee Fernandez, carried by unanimous vote to approve the South Valley site improvements to include an additional classroom, food service area, and a shade structure (covered food area) to be completed within the identified budget. Administration will design the project not to exceed the Capital Facilities/Redevelopment Fund 26 balance of \$1,464,474.

Penny Lauseng, CBO, reviewed the timeframe for when the 7/11 Committee deemed the Hopland and Redwood Valley school properties surplus, which was in 2017. Since then the district has been working towards a favorable solution for both surplus properties.

Penny reported that at this time the GMB realty partners has expressed interest in the Hopland property. A temporary access agreement allows GMB realty partners right of entry to our Hopland property for the purpose of conducting a feasibility evaluation including, without limitation, the right to conduct a physical plant review of all structures and systems by entering and inspecting the buildings and to conduct soils and environmental analysis.

EDUCATIONAL PROGRAM

Three Year Strategic Plan Process Update

Superintendent Kubin informed Trustees that we are on track for updating our three year strategic plan and that Steve Zuieback will be facilitating our initial process with stakeholders into the revision of our plan and then we will be doing focus groups thereafter, and the Board will be involved along the way.

As part of that we are still doing some visits, we visited a high school in San Diego this week, Fisher Frey. It has a health sciences/middle college program and places kids in internships 3 days a week. CALI arranged for the visit; we also plan to visit Roseland School District in Santa Rosa area and a K-8 district in Southern California. As part of our strategic plan process Steve Zuieback has recommended that we bring in external providers into our process on the first day to help us think about best practices and strategies around the state beyond Mendocino County.

Follow-Up Actions/Strategies from
District Learning Visits: Preliminary
Scholastic Aptitude Test (PSAT)

Katie Sommer, Assistant Superintendent, provided an update on how we are preparing for administering the PSAT. In gearing up, we have sent a letter to parents, careers and college going for seniors who don't have to take the test. All students need calculators and can't use the ones on their chromebook, so we've purchased the calculators. We are piloting and provided talking points to administrators and teachers. Katie expressed that we are excited and this is a large pilot project.

Trustees expressed thanks to all folks as they acknowledge how much work it takes to put this on. Trustee thanked Katie for following up and doing this, as we talked about this after our Southern California district visits, thanking her again for the work that has been put in to this pilot and for keeping the Board informed.

Talking Points: Goal One of the Ukiah Unified School District is to design and implement an educational program that prepares students for success in college and/or careers. This year we added a new action to reach that goal by providing the PSAT to all students in grades 8-11. The idea of piloting the PSAT for all students came from our visits to Districts that have similar demographics and are having more success with their most at-risk populations, and have created a strong college going culture.

Equity is a major focus in our district. We want all students to have the opportunity to get ready for college and careers. Some students may not have family at home who have experienced the process of getting into college and know the benefits of taking the PSAT.

- 22% of district parents have a college degree or higher
- 22% of district parents have some college
- 33% of district parents have a high school diploma
- 19% of district parents have not graduated from high school
- 4% of district parents decline to state

Ukiah USD is continuing to develop a college going culture. Through PSAT results we can verify that students are placed in appropriate classes and counsel students who do well on the PSAT into A-G courses if they are not on track. Giving the PSAT to all students allows them to prepare for the SAT by identifying areas they need to study or

classes they need to take. This way the SAT is not viewed as an unknown or an obstacle and gives the students opportunities to improve before taking the SAT.

The PSAT is also the National Merit Scholarship Qualifying Test. This allows students to get information regarding scholarships and other important college information. When students sign up to receive their scores, they begin to receive emails with college information. When students link their College Board and Khan Academy accounts, students get a personalized study plan based on their results on tests like the SAT, PSAT/NMSQT, or PSAT™ 10, so they can focus on the skills they need to work on most.

Superintendent Report

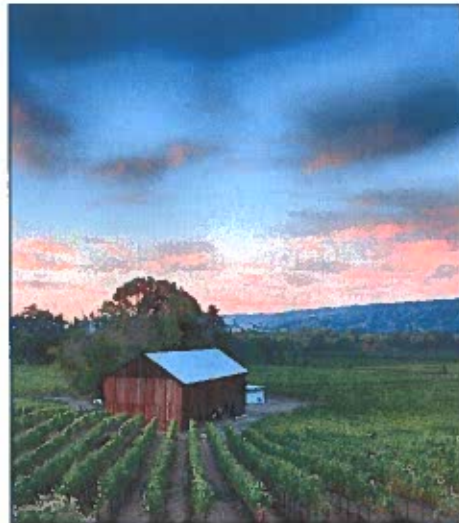

- Ukiah Unified serves approximately 6,000 students, ranging from preschoolers through adults.
- Comprises six neighborhood elementary schools, two middle schools, and a comprehensive high school.
- In addition, the district offers early education preschools, independent learning opportunities for elementary and high school students, an alternative education high school, and an adult education program.
- Ukiah USD serves students from the city of Ukiah, and the communities of Redwood Valley, Calpella, and Hopland.



Challenges Facing UUSD Schools

- Most schools were built many years ago and all show signs of aging
- School facilities require upgrades to support 21st century learning
- Aging classrooms and other instructional facilities need repairs
- School safety improvements, including fencing, are necessary to support continued quality education



Facilities Master Plan

In 2017, UUSD engaged experts and the community in a Facilities Master Planning process to identify and prioritize school repair needs and determine costs.



Facilities Master Plan



- Parents, students, teachers, staff and community members were involved in the collaborative process
- More than 40 participants provided input from January to October 2017

Cost Escalation

- Since completion of Facility Master Plan in 2017, many factors have contributed to the increase in the cost of upgrading existing facilities and building new facilities
- Resulting in a cost escalation on average 10% per year since 2017
- Cost estimates in this presentation are based on 2017 estimates



All Weather Fields



- Fields have been a concern at almost every campus
- Maintenance is needed at some level, but the level of repair/replacement varies per campus
- All weather turf is needed to ensure student/community use throughout the year



All Weather Field – Ukiah High School



- Committee in place to explore solutions and recommendations, including costs of artificial turf field
- Impact to Students/Athletes – Fields are outdoor classrooms to 1,200 students/day. Ability to offer year-round healthy, outdoor activities
- Committee determined a high priority need to build an artificial turf field at Ukiah High School

Potential State Funding Match

- UUSD would be eligible for approximately \$20 million in state funding match:
 - Relocatables: \$10,250,000
 - Permanent: \$9,350,000
- This assumes a local match of approximately \$13 million:
 - Relocatables: \$6,800,000
 - Permanent: \$6,300,000



Local Resources Needed

- The UUSD Board is considering placing a measure on the March 3, 2020 ballot to fund school facilities upgrades
- A proposed measure would extend the current tax rate to no more than \$60 per \$100,000 in assessed home value (not market value)
- The measure would generate up to \$88 million in locally controlled funding



Fiscal Accountability Measures

- All funding would stay local to support Ukiah Unified schools and could never be taken away by the State
- No funds could be used for administrators' salaries or pensions
- A Citizens' Oversight Committee and independent audits would be required to ensure all funds are spent as required by law
