Trustee Jackson acknowledged the amount of effort that staff have put into supporting this student in this expulsion. She moved approval to uphold the panel's recommendation with the addition of the option that should the student complete the rest of the current school year adhering to the terms of his rehabilitation contract, including 95% attendance and at least a 2.0 grade point average, and on the recommendation of MCOE Alternative Education staff, that the student be allowed to start 9th grade on the first day of the first semester of the 19/20 school year. The student would also need to successfully complete summer school in the Alternative Education program if recommended by the MCOE staff. The

student would have the option of returning to whatever high school District staff recommends. If the student fails to meet that criteria, the student will return to Community School.

President Knell noted this resolution proposes a change to By-Trustee Area Elections, starting in 2020.

The following individual addressed the Board on this item:

-Jon Marker: spoke in favor of this resolution, not only for what it means for the community, but in the process it can build community engagement; timing of drawing district lines before the election, and with Census 2020; opportunity to look at elementary district lines, enrollment patterns and equity across the district; opportunity to build a taskforce of community members to educate the public about how lines will or will not overlap with city lines; offered to help.

President Knell clarified that the governing boundaries will include the high school district.

Trustee Jackson addressed Census 2020, noting the importance of making sure whatever demographer consultant we use, is using the best data.

Minutes:

Dr. Mayra Perez reviewed previous information that was shared with the Board regarding enrollment projections in the elementary district, which are projected to remain flat or slightly decrease over the next several years. She also reviewed the implications for Short School, as it has no attendance area, and will again not have a kindergarten next school year.

Dr. Perez emphasized that we want to be very mindful of how the size of a school can impact student learning, family engagement, the overall success of the school community and more.

Four meetings with the Short School community were held over the past few months about how we can best serve the school community in the short and long-term given the enrollment information. In total, about 80 Short parents attended; approximately 100 Short students are impacted. At the meetings, there was a focus on sharing enrollment updates and hearing concerns, ideas and questions, as well as a focus on hearing ideas about potential options and paths forward. Dr. Perez also reminded the Board that Laurel Dell Principal Pepe Gonzalez will provide oversight to both Laurel Dell and Short next year.

After hearing from the Short community, staff are recommending it is in the best interest of students and families for Short to remain open the entire 19/20 school year, with grades 2-5 and TK. It was also recommended that a merge with Laurel Dell when the campus is projected to be complete mid-year was determined to be too complex and of concern for families, and will be looked at as a future option.

In addition to the recommendation, Dr. Perez stated that beginning in August 2019, the District intends to collaborate with all stakeholders to create a "roadmap" for the future of Short. The group will brainstorm, review, discuss and plan recommendations to present to the Board by Jan. 2020 or earlier, on factors such as the potential transfer of students and families to Laurel Dell; the transfer of teachers and staff; as well as possible options for future use of the Short School facility.

In response to Trustee Jackson's question regarding families with multiple students going to multiple schools, Dr. Perez noted staff are asking families about how best to accommodate families staying together, trying to prevent them from having to go to multiple schools. Mr. Gonzalez provided information about a communication that will be sent to families to help guide these placements.

Trustee Jackson expressed a need to talk about whether TK is the best use of funding, as it provides for only a small cohort of families.

Staff responded to further questions regarding family visits to other schools; how open classroom space will be used; a flat enrollment trend being seen around Marin; and the new Laurel Dell campus that will have 3 new classrooms and be able to accept Short students.
