

**CHANGE ORDER NO. 1**  
**TO AGREEMENT FOR PROFESSIONAL SERVICES**  
**WITH RUGGERI-JENSEN-AZAR**  
**BROWNELL MIDDLE SCHOOL MODERNIZATION PROJECT**

In connection with the Agreement for Professional Services dated as August 27, 2018 (the "Original Agreement") between the GILROY UNIFIED SCHOOL DISTRICT ("District") and **RUGGERI-JENSEN-AZAR** ("Consultant"), which consists of the Original Agreement, and several Exhibits, the Consultant and the District hereby amend the Original Agreement pursuant to this Amendment No. 1 (the "Amendment," and together with the Original Agreement, the "Agreement"), by and between the District and the Consultant, as follows:

1. **Compensation.** The amount specified as compensation in **Paragraph 4** of the Original Agreement is hereby deleted and replaced with the following amount: **\$46,933.00**.
2. **Services.** The services described in the Original Agreement are hereby amended:
  - a. Original Agreement - 8/27/18 - \$18,950.00
  - b. Contract Increase 10/16/18 - \$18,183.00
  - c. Change Order #1 3/11/19 - \$9,800.00
3. **Additional Term.** The following new provision is hereby added to the Original Agreement: **Due to additional expenses including: Plat & Legal Description; Parcel Map; Coordination during Final Design.**
4. **Effective Date of Amendment.** This Change Order No. 1 shall be dated and in full force and effect on the date signed by the District, as indicated below.
5. **No Other Changes; Entire Agreement.** All provisions of the Original Agreement not specifically changed herein remain in full force and effect. This Amendment, together with the Original Agreement, constitutes the full agreement and understanding of the Parties with respect to the matters therein and herein contemplated. Further provided that, if any term or provision of this Amendment shall be in conflict with any term or condition of the Original Agreement or any Exhibits thereto, the provisions of this Amendment shall control.
6. **Execution.** The person(s) executing this Amendment on behalf of the Consultant warrants and represents that Consultant has vested authority on such person(s) to execute and deliver this Agreement and to perform the services contemplated hereunder and that this Agreement is valid and binding on Consultant.
