9.1. Escalon High School Board Representative

Minutes:

Student Board Representative, Hailie Webster reported on events taking place at Escalon High School. A dodgeball tournament will be taking place tomorrow, where teachers and students will participate. ASB elections have taken place, and Madison Bavaro will be next year's Student Board Representative. Senior awards are May 22, 2019.

9.2. Period 8 Attendance

Minutes:

Superintendent Costa reported on period 8 attendance for the 2018-2019 school year. Period 8 was down .22%. Year to date the district is still up compared to prior year by .07%. Four schools were up over last year with ECA leading the schools with a 98.53% and El Portal coming in second with a 96.92%.

11. SUPERINTENDENT'S REPORT

Minutes:

Superintendent Costa asked the board for direction on holding a board retreat in May. The purpose of the retreat is to tie up some loose ends at the end of the school year and plan for the upcoming school year.

A group of 18 teachers along with Mr. Chavez have been piloting possible new K-5 curriculum. Under Mr. Chavez's direction the committee has done a thorough job of vetting the curriculum options.

Construction is progressing at three sites, Collegeville Elementary, Gateway Academy and Dent Elementary. Brayton had a site pre-construction walk through with his subcontractors on April 11, 2019. The board will have an action item concerning the Dent construction on the May 7th board agenda.

Superintendent Costa and Trinette Marquis recorded a promotional video on the First Responder CTE Pathway today. They were able to witness 4 student firefighters crawl through an obstacle course simulating a fire and rescue a downed firefighter. They brought him out of the fire and he was immediately cared for by the EMT team who provided first aid and then transported him to our ambulance. It was amazing.

11.1. March 2019 Financial Report

Minutes:

Superintendent Costa reported on the March 2019 Financial Report. The district received 18.8 million for fund 1 of our budgeted revenue of 28.9 million. We have expended 19.1 million of our budgeted 28.4 million. For fund 9 we are still anticipating deficit spending of 1.1 million due to the construction and moving of Gateway. Fund 21 currently has 4.1 million and fund 35, the state match for construction, currently has 7.8 million for a total available of 11.9 million for Dent modernization/construction.

12. PRINCIPALS' REPORTS

Minutes:

Anthony Varni, Principal of Dent Elementary reported on events taking place at his site. He thanked his Assistant Principal Robert Fyke for his hard work during CAASPP testing. Testing went very well, virtually no technology issues. Screening went very well for incoming transitional kindergarteners and kindergarteners. Third graders did an amazing job on their unit on the life cycle of eggs and chickens.

Dawn Webster, Principal of Collegeville and Farmington Elementary reported Open House for Farmington took place tonight, with 66 students attended. Collegeville is having its Open House tomorrow. Kevin Bracy will visit both sites on Thursday, April 18th.

Jennifer Klopatek-Driscoll, Principal of Gateway Academy reported CAASPP is taking place at her site. Gateway conducted home visits to all its families to discuss CAASPP testing, only ten families opted out. Technology went great during testing. Her site is currently in the process of ordering individualized curriculum for next year.

Julio Zambrano, Principal of Van Allen Elementary reported kindergarten assessments went very well at his site. Love Escalon helped at the Van Allen garden. A Red-Carpet event will take place on April 30th to cheer on students for the first day of testing. Science Night will take place tomorrow, with great vendors.

Mark Vos, Principal of El Portal Middle School reported CAASPP testing went very well at his site, with almost no technology issues. Assistant Principal Mike Gaston will be traveling with students this year for the end of the year field trip to Alcatraz. His site is currently looking at setting cut off dates and GPA requirements to participate in the promotion ceremony. Students are working very hard at meeting the grade requirements to be able to participate.

George Megenney, Principal of Vista High School reported CAASPP testing is done at his site. Graduation rate this year at his site is great.

Eric Simoni, Principal of Escalon High School reported CAASPP went very well thanks to Assistant Principal Jason Furtado. He mentioned how popular the first responder program is and what a great job the students are doing. WASC review will take place next week. Academic Awards are taking place on May 6th. This year there are 182 students on track to graduate.
