The Why?

The District's underlying premise is that schools should not delay providing help for struggling students until they fall far enough behind to qualify for special education, but instead should provide timely, targeted, systematic interventions to all students who demonstrate the need - as soon as they demonstrate the need. 116

Communication/Planning: Hart MS Staff (con't)

- Continued RTI staff development at Solution Tree/RTI² conference in San Francisco. 8 teachers, one counselor and the Principal attended.
- RTI² Readiness Survey administered to staff during collaboration in January 2019. At that time 81% of teacher were in favor of bell schedule change.

SURVEYS

• Parent survey was open for two weeks from 3/8/19 to 3/22/19 = 292 responses.

 Student survey was given in 6th and 7th grade ELA Block classes on 3/7/19-3/8/19.












Hart Middle School- RTI2 Parent Response





Would it be helpful for you to have a 30 minute period twice a week to get help from a teacher, do work, or participate in an enrichment activity?



What do you see as your greatest need(s) that could be addressed during this 'tutorial period'? Check all that apply






Hart Middle School- RTI² Student Response
