History of REALM Charters

- BUSD Board granted separate charters for REALM Middle School and High School in June, 2009
- Charters renewed in December 2015 for current term (7/1/2016-6/30/2021)
- After February 2018 Notice of Violation, Board granted Request for Material Revision to merge middle school and high school under single charter.

Enforcement History

- Notice of Violation: January 26, 2017
 - Fiscal Issues
- Notice of Violation: February 2, 2018
 - Fiscal Issues
- Notice of Violation: September 26, 2018
 - Out-of-County Site

Current Proceedings

- Notice of Violation February 2, 2019
 - Approximately \$1.5 million in unpaid debts
- Delinquent in payments for STRS
 - Impact on teachers' retirement benefits
- Problems with budget process
 - Failure to submit final audit report by December 15, 2018
 - Failure to carry over negative fund balance after merger

Current Proceedings

- Board approved Notice of Intent to Revoke on April 10, 2018
- REALM submitted Request for Material Revision on March 12, 2019 proposing merger with Compass Charter Schools

Request for Material Revision

- Acquisition by Compass Charter Schools, Inc.
 - Governed by Compass governing board
- REALM financial obligations
 - Compass has provided to REALM three (3) loans, in sums of \$100,000, \$250,000, and \$250,000
 - Fourth loan of \$250,000 should the material revision be approved.

Request for Material Revision

- Addition of non-classroom based program
- Budget depends on significant and steady enrollment growth:

Request for Material Revision

- “A material revision of the provisions of a charter petition may be made only with the approval of the authority that granted the charter.” (Education Code section 47607(a)(1))
- Standards for Evaluating Request: “Renewals and material revisions of charters are governed by the standards and criteria in Section 47605, and shall include, but not be limited to, a reasonably comprehensive description of any new requirement of charter schools enacted into law after the charter was originally granted or last renewed.” (Education Code section 47607(a)(2))

Request for Material Revision

- Grounds for Denial:
 - The charter school presents an unsound educational program for the pupils to be enrolled in the charter school.
 - The petitioners are demonstrably unlikely to successfully implement the program set forth in the petition.
 - The petition does not contain an affirmation of each of the conditions described in [Education Code section 47605], subdivision (d).
 - The petition does not contain reasonably comprehensive descriptions of all of the [required 15 elements set forth in Education Code section 47605.]

Issues Regarding Material Revision

- Will Compass pay off all of REALM's debt?
- Non-classroom based program
 - Did REALM provide sufficient information regarding curriculum, instructional materials, instructional strategies, assessment measures and goals, etc.? (Element A – Educational Program; Elements B & C – Measurable Pupil Outcomes)
 - Does REALM comply with Ed. Code 47612.5 in the event that non-classroom based instructional minutes exceed 20%?

Issues Regarding Material Revision

- How will the Compass governing board remain accessible to the REALM Community?
 - Compass' 3 charter schools are in Fresno, Los Angeles and San Diego
- Will Compass recognize BFT as the exclusive representative?
- Does the proposed Compass acquisition cure the issues in the Notice of Intent to Revoke?
- Can REALM realize a 200-student increase in enrollment by 2019-2020, and grow in the next 5 years as projected?

 - Deny Request for Material Revision
 - Impact on REALM's future operations
 - Impact on Notice of Intent to Revoke
 - Consider REALM's prospects for future sustainability without Compass acquisition
