Dear Suzanne,

We are reaching out to request a territory transfer for parcel 527-09-029 from the Union School District to the Los Gatos Union school district.

We own the parcel 527-09-029 since December, 2015 and reside in the house built on that parcel (15690 Gum Tree Lane, Los Gatos) together with our three kids. Based on our review of school district boundary maps, it appears that the boundary between Union School District and Los Gatos School district is touching our parcel, but the property is allocated to the Union School district.

Our kids are 11, 9 and 5 years of age and currently attend Union Middle School and Alta Vista elementary school in the Union School district. Today, we drive all our kids to their respective schools, but would like for our older kids to start commuting independently by bicycle. This will alleviate us from driving for drop off and pick up daily, but also, very importantly, enable our kids to learn how to be self-sufficient at an early age.


Unfortunately, bicycling from our house to any of the Union School district schools is prohibitively dangerous as it requires traversing a section of G10 (Blossom Hill Road) that has very narrow shoulder, no Eastbound bicycle lane and a high speed limit. Conversely, commute route from our house to Los Gatos schools is via a section of Shannon Rd that is substantially safer for a bicyclist because of 25mph speed limit, low traffic flow and ample shoulder space in both directions. I have attached maps and pictures of the two commute routes that I hope help illustrate this.






Commute from 15690 Gum Tree, Lane to Union Middle School
