Approximate times listed; each succeeding round will begin at the conclusion of the previous round. Coaches and wrestlers should remain in close proximity to the arena in order to be ready for each match.

Mat Assignments:

Beginning with Consolation Round 1 on Friday, February 22, 2019, the girls will compete on mats 1 – 5, and the boys will compete on mats 6 – 10. Quarterfinal matches on Friday will be 1 – 4 for girls, and 7 – 10 for boys. Championship Semifinals will be conducted on six mats, alternating genders and weight classes to conclusion of championship semifinals. Medal round matches will feature the girls on mats 1 – 3 and the boys on mats 4 – 6. Championship Finals will be conducted on two mats with the girls on the North end of arena and boys on the South end of arena.

Awards Schedule:

2 Rounds of Finals for Boys and Girls, followed by awards for boys and girls 1st finals. Awards for both genders will be distributed at the conclusion of each finals round from that point forward. Team, Champ of the Champ, and coaches awards will be distributed at conclusion of finals program. Awards stand will be located adjacent to the head tournament table on the arena floor.
