


Enclosed is the ballot material for election of your region's or subregion's representative to CSBA's Delegate Assembly. The material consists of the ballot (on red paper), required candidate biographical sketch form, and if submitted, a résumé. In addition, you will find a "copy" of the ballot on white paper so that it may be included in your board agenda packet, if you choose to include it. **Only the ballot on red paper is to be completed and returned to CSBA.**

The board as a whole may vote for up to the number of vacancies in the region or subregion as indicated on the ballot. For example, if there are three vacancies in the region or subregion, the board may vote for up to three individuals. Regardless of the number of vacancies, each board may cast no more than one vote for any one candidate. (The ballot also contains a provision for write-in candidates; their name and district must be clearly printed in the space provided.)

The ballot must be signed by the Superintendent or Board Clerk and returned in the enclosed envelope; if the envelope is misplaced, you may use your district's stationery. Please write **DELEGATE ELECTION** prominently on the envelope with the region or subregion number on the bottom left corner. **Ballots must be postmarked by the U.S. Post Office on, or before, Monday, March 16, 2015. No late ballots will be accepted.**

Election results will be available on CSBA's website no later than Wednesday, April 1. If there is a tie vote, a run-off election will be held. All re-elected and newly elected Delegates will serve two-year terms beginning April 1, 2015 – March 31, 2017. The next meeting of the Delegate Assembly is on Saturday, May 16 – Sunday, May 17 at the Hyatt Regency in Sacramento.

While California is large and diverse, most districts share the same general challenges and CSBA should be the central place for solutions.




Why are you interested in becoming a Delegate and what contribution do you feel you would make as a member of the Delegate Assembly?

Student health & wellness - To work on the community school model in order to help increase the health and wellness of all students so they can perform at their best, thus decreasing the achievement gap.



CSBA's Delegate Assembly sets the general education policy direction for the Association. As a member of the Delegate Assembly, please describe what your top three educational priorities would be, and why they are important to the Association.

- Financial Stability for Districts: The reserve limit cap that was passed with Proposition 2 this past November is dangerous for districts and needs to continue to be addressed with our Legislators. CSBA is working hard to promote change to this legislation and with our efforts, I believe change will be implemented.
- More Resources for Districts: The LCFF and Prop 30 (soon to expire) are positive steps in funding our CA schools, but we are still last in the nation and we must remind our Legislators and our constituents that our children deserve better. We need to continue to fight for more financial resources for our students.
- Educational Equity for all Students: The focus of the LCFF on providing more resources for student populations with greater needs is positive. We must invest in these students while also continuing to challenge all of our students, including those that are high achieving. Equity doesn't mean equal, but it means giving each population what they need to be successful.

CSBA activities: Since I was elected to the Sunnyvale board in 2011, I have greatly enjoyed being involved with the SCCSBA. 
