

WHERE KNOWLEDGE GROWS

THIS CONTRACT was made and entered into on July 15, 2019, between Sylvan Union School District (“**District**”) and Overhaul Construction (“**Contractor**”).

WITNESSETH: The parties do hereby contract and agree as follows:

1. The **CONTRACTOR** shall perform agreed upon services for a total contract price of:

Forty Two Thousand Eight Hundred Fifty and 00/100 Dollars (\$42,850.00).
2. The following services: Freezer room remodel at Sylvan. Per attached proposal.
3. The term of the contract shall begin on August 15, 2019 with work to be completed on or before September 13, 2019.
4. The **CONTRACTOR** shall not commence work under this Contract until the insurance required under Paragraph 23 of the **Terms and Conditions** and satisfactory proof of such insurance has been submitted to the **District** and said insurance has been approved by the **District**.
5. Payment Schedule – payment for the work shall be made in lump sum upon final completion of the project, District’s written approval of the work (which approval shall not be unreasonably withheld), and receipt of correct invoices. Terms: Net 30 days.
6. Inspection shall be performed by the Maintenance & Operations Supervisor, Inspector of Record, or other authorized representative.
7. The Contract includes the general terms and conditions as printed and set forth on the following pages, and the **CONTRACTOR**, by executing this Contract, agrees to comply with all such general terms and conditions.
8. The **CONTRACTOR** shall guarantee all labor and material used in the performance of this Contract for a period of one year from the date of final written approval by the **District**.
