6.1. AB 1200 Public Disclosure of Collective Bargaining Unit Agreement (SMETA)

Sue Wieser, Assistant Superintendent of Human Resources, presented information about the AB 1200 Public Disclosure of Collective Bargaining Unit Agreement for the San Mateo Elementary Teacher's Association (SMETA) for the new tentative three-year successor agreement, 2019-2022.

The Board thanked Ms. Wieser for all the hard work that went into reaching this agreement. Ms. Wieser stated that it was a collaborative effort and appreciated being able to settle in a timely manner.

6.2. SMETA-SMFCSD Tentative Successor Agreement/Salary Schedules (v)

Ms. Wieser presented information regarding the Tentative Agreement reached between the District and the San Mateo Teachers' Association (SMETA) for the new three-year Successor Agreement, effective July 1, 2019 through June 30, 2022 and requested Board approval.

Public Comments:

Randi Paynter stated that the agreement is encouraging as it reflects the District's priorities such as stipends of Title 1 teachers, increased stipends for RSP and SDC teachers as well as stipends for Montessori trained teachers. She asked about 1) if the District grants stipends to bilingual teachers whether they work in a dual immersion program or not 2) do all Montessori teachers get the stipend whether they work in a Montessori program or not? Ms. Wieser responded that teachers who hold a certification for second language skills receive the stipend and that only teachers who work in Montessori schools receive the stipend.

Motion Passed: IT IS RECOMMENDED THAT THE BOARD OF TRUSTEES APPROVE THE TENTATIVE SUCCESSOR AGREEMENT WITH THE SAN MATEO ELEMENTARY TEACHERS' ASSOCIATION (SMETA) AS NEGOTIATED. Passed with a motion by Audrey Ng and a second by Kenneth Chin.
