### I. OPEN SESSION/ROLL CALL 6:00 PM

President Knell convened the meeting to Open Session at 6:03 PM.

IV.1. UPDATE: (ESD/HSD): Labor Unions: CSEA, SRTA, SRFT

IV.2. BOARD BUSINESS (ESD/HSD): Public Hearing Public Input Session On Draft Trustee Area Boundary Maps

#### Minutes:

Demographer Shalise Tilton from National Demographics Corporation provided an overview of the process to date:

- Two public hearings have been held and draft maps released yellow, purple and green
- The mapping tool was discussed at the Community Forum that was held
- There is an upcoming Community Forum on July 17 at VV
- At the Aug 12 Board meeting maps will be presented again
- For this evening, the Board can only speak to maps that have been posted at least 7 days in advance, which are the red yellow and green maps
- For the next hearing, all submitted maps will be grouped by characteristics

DWK attorney William Tunick reviewed the remaining steps of the process:

- The District is holding one more hearing than required by statue
- -Hearings will be held on Aug 12 and 26
- Adoption of a map will be at the August 26 Board meeting
- After map adoption, the proposal goes to the County Committee which will hold a Public Hearing and approval of the map. The Public Hearing has to be held within SRCS boundaries
- State Board of Education (SBE) action on the district's request to waive an order of election, happens at the same time as the County Committee action. A Resolution to ask SBE to waive the requirement for election will be brought to the Board on Aug 12
- The Novato USD redistrict mapping waiver request will be at the SBE about the same time as SRCS.

Information shared on maps:

- Assigning election year to each of the districts, 2020 and 2022, the board determines the sequencing
- All at-large election terms will be completed
- -CVRA state law and federal law need to be followed: equal population; using 2010 census data; no racial gerrymandering need communities of interest; achieving compactness; maps should be contiguous; follow man-made boundaries; respecting voters' wishes; avoid pairing; and leave up to the voters
- Maps must be posted 7 days prior to when the Board can talk about them

- There is a total of 18 maps on the website and on the interactive map viewer; 5 submitted by the public and one drawn by NDC based on the first community forum (map 105). 49 maps drawn by students -15 were not population balanced; 3 maps submitted by public if comments were added they are on the maps.
- Discussion of Citizen Voting Age Population (CVAP), voter registration, age, education, children in household, housing status, household income.

In response to President Knell's question regarding lowering voting age and extending the franchise to non-citizens, Mr. Tunick responded that those questions would be dependent on an amendment of the City Charter and Government Code and would be a parallel process.

President Knell opened a Public Hearing on Draft Trustee Area Boundary Maps at 6:33 PM.

The following public comment was heard:

- Zachary Griggy: he drew maps 101 and 102, trying to avoid splitting neighborhoods as much as possible and unifying various areas of SR; will draw up more maps removing Spinnaker and Bay Point
- Unidentified speaker: using Adrian Way as a dividing line is not good.

Trustee comments on maps:

- Moving Spinnaker out defeats the neighborhood in terms of demographics
- Maps S9 and S2, submitted by Enrique Vasquez recognizes Montecito and Canal neighborhoods as similar interest
- With Santa Venetia, the ridgeline between north and south is important; would like to see this line recognized and respected

President Knell closed the Public Hearing at 6:49 PM.
