9. STAFF REPORTS:

9.A. Equity Audit Planning Process for San Rafael City Schools (HSD)

Minutes:

Dr. Mayra Perez introduced The Education Trust West consultants Rachel Ruffalo and Dr. Mayra Lara, and Dr. Juliet Schiller from Marin Promise who were present for the Equity Audit Report. She noted Marin Promise's partnership across the county with their "Every Door Open" Initiative - no doors are closed to college and career, and the \$150K grant they received to do the work, including providing financial support to SRCS to conduct an equity audit. A report on the findings will be presented and a resolution later on this agenda is being brought for adoption of the next phase for 'Blueprint planning.' Phase 3 will be how to implement supports that are needed.

Dr. Lara provided an overview of the Equity Audit work which looked at A-G requirements and college and career readiness. A mixed method study was done - both qualitative and quantitative, with the involvement of District Office personnel, forums at each site; surveys among students and parents, and school teachers and staff, 3 community conversations, and transcript analysis of a cohort of 645 2018 students.

Ms. Ruffalo shared highlights of the report and data from surveys done with students, parents and staff was shared.

Next steps will be to take the Audit Report and findings, and recommendations to create a plan that is a best fit for the district for adoption and implementation, establishment of monitoring systems, and ensuring meaningful access to the full curriculum, including Honors and AP, and using strategies for success.

Dr. Perez reviewed the second phase which is development of the 'Blueprint.' Work will continue with Ed Trust West staff. A committee with a team from each site will be developed to study results of the Audit with staff. A root-cause and symptoms process will be used. Clear data will be used to develop a plan.

The Board, staff and consultants held discussion which included: students who want to go into the trades and not college; the definition of co-partnering; newcomers and students with special needs, and increasing A-G classes

The following individuals addressed the Board regarding this item:

-Tracey Lanier, 10,000 Degrees: spoke in support of this work

- Elizabeth Rodriguez, 10,000 Degrees: spoke in support of expansion of the UP program to provide guidance to students/families for access to A-G and college

- Jon Eldridge, COM VP: the need to look at systemic changes; opportunities that the COMPASS program partnership has brought to students; COM can help with the Equity Audit planning and taking the next step; addressed questions from President Knell regarding remedial courses

- Kaila Itsom, 10K Degrees Fellow, Alumni from SRCS and SSU graduate: students in HS are not getting the information regarding A-G early enough; counseling not mentioning it; she was fortunate to have 10K Degrees advisors provide the information to her which led her to opportunities to continue her education; tracked kids don't get the information

- Maria Rodriguez, 10K Degrees College Access Fellow, graduate of SRCS schools and Sacramento State: the importance of A-G eligibility making a difference in students' lives; 10K Degrees support equity for students - maximize their options to keep all doors open. President Knell engaged in conversation with Ms. Rodriguez about doing earlier outreach with students in their Freshman year.

- Superintendent Hogeboom read a letter on behalf of SRFT, who asked it to be part of the meeting record:

Dear Trustees, District Staff, and Community Members :

The San Rafael Federation of Teachers supports and endorses well-planned initiatives that improve educational experiences and outcomes for students, especially those designed to address inequities that exist within our school system.

For any initiatives to succeed, however, there must be thoughtful outreach to site faculties and staff to allow for those who work directly with student to ask questions and give input. As far as we know, the results of the Equity Audie have not been advertised and made available to the sites.

Therefore, our Union leadership respectfully requests that the Board delays making a Resolution to Commit to Blueprint for Equity Planning and Implementation until:

- *The Equity Audit Report has been freely available to the sites. We would expect to see presentations at staff meetings.*
- *Questions and input about this initiative have been collected from faculties and staffs at the sites for the Board and for District to consider.*
- *More analysis is completed regarding the costs to the District over the course of this initiative. Tonight's agenda item Number 12.K reads, "There is no fiscal impact to the District." But the attached Resolution reads that the District will "Commit the financial and human resources to successfully complete the Blueprint for Equity Planning process." The District needs to articulate what these "financial and human" resources will be in the coming years..*

The success of any initiative largely depends on a common understanding of what the initiative will look like, and a common understanding of what it will take to be successful. Stakeholder support, especially from those at the sites who work with students, will be essential to successfully meet the recommendations as described in the Equity Audit Planning Process in the High School District.

-Jon Marker, former Marin Promise Executive Committee member, YLI: more systemic interventions are needed; address counseling; look at Dashboard year after year; build trust and transparency across the system

- Cassandra Lane, SP teachers: include elementary and middle school stakeholders on the Blueprint committee

Trustees and staff discussed supports for students in AP and Honors classes, the evidenced engagement of students in arts and electives; supports for newcomers, ELL, students of color and low income; concerns about the research method and funding, and making sure teachers and counselors are involved; talking about A-G with students as early as middle school; the idea of a separate taskforce on newcomers and counseling services; the importance of family involvement and engagement in the college process for students.

Superintendent Hogeboom expressed thanks to Ed Trust West and Marin Promise for their partnerships. He noted that A-G is not everything, but it is important. The Equity Audit was Step 1; the 2nd step is the Blueprint plan. This report will be shared with principals, faculty and staff at all sites. He noted in response to Board President Knell's suggestion for a separate taskforce, that the team that will develop a Blueprint is the steering committee; a separate taskforce is not needed. The 3rd step is plan implementation. He noted that thanks to funding support from Marin Promise, the district's only contribution has been \$10K and a minor cost of some sub-time. This is a good investment for important work of the district.

9.B. Capital Facilities Report (ESD/HSD)

Minutes:

Dr. Dan Zaich provided highlights of Electric Vehicle Chargers (EVCs) to be installed at 8 district schools, as a follow-up to a 2018 presentation to the Board, reviewing: partnerships with PG& E, Transportation Authority of Marin (TAM) and Marin Clean Energy; Phase 1 and 2 of the plans; grant funds that have supported this project; estimated operating costs, and plans to develop a policy regarding use of chargers. He noted the addition of EVCs aligns with the LCAP sustainability goals and building the District's branding toward Green Initiatives.

Dr. Zaich provided a quick review of the DSA drawings at all 8 sites that showed location of the chargers. He noted at Glenwood and San Pedro, they will be paired with the solar PV parking structures. In response to President Knell's comments regarding a dedication, Dr. Zaich recommended having a soft policy first to incentivize use of the chargers with staff. Trustee Kertz recommended having one district level policy for all sites, noting the importance of not using staff time to police or monitor the policy.

The following individual addressed the Board on this item:

- Cassandra Lane, SP teacher: 20 parking spots have been lost at SP due to construction; do not take parking spots from teachers; incentivize to help teachers who are using EVCs during the day

Dr. Zaich noted in response to Ms. Lane's comments that the 2nd phase after construction at San Pedro will be removal of the portable so parking spaces will be restored.

10.B.1. Report: Trustee Area Boundary Maps Process

Minutes:

Ms. Perrino briefly reviewed the spring and summer process and community engagement for the development of maps.

Doug Johnston of NDC provided an overview: involvement was high by a small interested group of community members; after selection of a map it will go the County Committee; all maps comply with Federal requirements; this has been a 3-stage process: 3 NDC draft maps were drawn, 6 maps by residents, 1 map at board request by NDC, student maps were submitted; the Board narrowed maps to 103, 105, 106, 107 at the last meeting ; other maps came in after the posting for that discussion; now there are 10 maps for Board review; the Board subcommittee came up with 108. Maps 103 and 103B are from the same person; 107and 107C included comments; Map 110 was drawn as a possible alternative after board discussion at the last meeting.

10.B.2. Public Hearing: (ESD/HSD) Public Input Session On Draft Trustee Area Boundary Maps

President Knell opened a Public Hearing on Trustee Area Boundary Maps at 7:45 PM.

-Zach Griggy: provided background on maps he submitted: 101, 102, 101B, 107, 107C and 109, and 110.

-Jon Marker: recommended maps 110 and 108; noted that the neighborhood west of Playa del Rey was excluded in the development of Map 108

Mr. Johnston reminded the Board that maps cannot be changed at this point.

-Cassandra Lane: her Map 103B includes a deviation under 1% population; she would be happy with maps 108, 109, or 110, all advocating for the Canal area; thanks for the process and being receptive

There being no further public comment, President Knell closed the Public Hearing at 8:03 PM.

10.B.3. Minutes:

Trustee Tuatagaloa noted he looked at the maps in terms of voter turnout numbers in 2016, which reflected a turnout of 26% Latinx in Map 108 and 33% Latinx in Map 110; He noted Map 110 has a better percentage for Latinx voters; the other two maps that are closest are 109 and 107C. These numbers are pushing him to favor Map 110.

Trustee Kertz noted her preference of Map 110 which she felt gets to the heart of what originated this request to move to by-trustee area elections. She noted the importance of identifying the Canal as its own represented district; 110 best supports that.

Trustee Jackson concurred with Map 110.

Trustee Llorens Gulati noted she favored Maps 109 and 110, but in the end go with Map 110.

President Knell noted his agreement with Trustee Tuatagaloa's point about voter turnout and expressed his preference for Map 110. He thanked Ms. Lane for her involvement and advocacy for the Canal in her maps, and on behalf of the Board, he expressed thanks to former SRCS student Zach Griggy for his work on the maps, specifically for developing Map 110.

10.B.4. Report: California School Board of Education Process to Waive Election Requirement To Alter Election System

Minutes:

DWK Attorney William Tunick reviewed the process now that Map 110 has been adopted by the Board:

-The Map will go to the County Committee on School District Organization who will vote in the next 3-4 months

- The final step in Education Code results in the calling for an election for a yes or no vote on the maps which the district would have to pay for; an off-cycle election would be very expensive and delay the implementation of the Map and it would not provide legal immunity for the district

- The State Board of Education (SBE) can waive an election through Education Code requirements; the SBE has waived elections for 250 districts to this point

- The SBE asks that districts do outreach out to stakeholders, community groups and union groups, noting that SRCS staff worked to gather input from these groups. Ms. Perrino noted that the District heard from all 3 union leaders that they showed support of a waiver of election, and the other groups were of no opinion.

In response to Trustee Jackson's question about whether it would be helpful to have District Board and/or staff presence at the county or state meetings, Mr. Tunick noted at the state level it is a more pro-forma process that will be on their November agenda, but the County Committee meeting will be a different story, noting that having support at that meeting would be helpful.

Minutes:

This item was pulled forward on the agenda for discussion.

Dr. Perez provided an overview of this resolution representing the District's commitment to do a Blueprint plan. In response to Trustee Jackson's comments regarding no financial information being provided with this agenda item, Dr. Perez responded there will be another \$10K contribution this year, plus the cost of 5 days of release time for teachers involved; estimated to be less than a \$35K investment. The Blueprint is a K-12 process. She clarified that with adoption of this resolution, the District is not committing to the recommendations as listed in the report; this will be the work of the committee to develop the recommendations.

In response to a question from Molly O'Donoghue regarding whether this will be a 50/50 expenditure, Dr. Perez noted that the \$10K will be a HSD expense, but the sub release time will be charged to the district of participating teachers.
