- a. Design changes will include landscaping, structural, civil and architectural in order to modify the trash enclosure, ADA parking stalls, fencing and gate to accommodate the agreed MOU between Park and Rec and the school district**

2. "Compensation and Payment" of our Agreement dated May 21, 2019 is hereby modified to allow for the additional fees required to implement the above changes. The present fee of \$846,600.00 and is hereby increased by a not-to-exceed fee of \$16,000.00. The revised fee is \$862,600.00.
  3. The contract completion date of after receiving the agreement is to remain the same.

All other conditions of our Agreement (and subsequent Amendment(s) set forth above) remain in full force and effect as originally stated.
