



PROGRAM AGREEMENT

Congratulations once again on being selected as one of only four elementary schools to participate in the Segerstrom Center for the Arts Disney Musicals in Schools program!

As discussed, Disney Theatrical Group and Segerstrom Center for the Arts will be providing your school with the following:

- A free license to produce and perform a Disney KIDS musical of your choosing (subject to terms and conditions specified in the licensing agreement).
- Free ShowKit materials.
- Free onsite support from a team of two Segerstrom Center for the Arts Teaching Artists for seventeen weeks (during a 90-minute school visit each week)

During our selection process we felt sure this program would excel at your school. **To ensure success, we ask the following of all participating schools, all of to which you agree by signing this Program Agreement below and accepting the above license, materials and support:**

- A commitment from the School Team to drive the project, from beginning to end.
- An eagerness by the School Team to collaborate with the Segerstrom Center for the Arts Teaching Artists, Segerstrom Center for the Arts Education Staff, school administration, students and parents.
- Open communication with Segerstrom Center for the Arts Teaching Artists and Segerstrom Center for the Arts Education staff.
- An agreement that your school facilities, students and teachers may be documented (via video and/or still photography) for use in connection with Disney Musicals in School and The Walt Disney Company in discussing Disney Musicals in School, and further agreement to ensure that all related releases at the faculty and student level are appropriately signed and returned to the Segerstrom Center for the Arts in a timely fashion.

- A production budget, of any dollar amount, which will be communicated to the Segerstrom Center for the Arts Teaching Artists. Schools are expected to firmly commit to the amount they dedicate to the project.
- A guarantee that the agreed upon space is available for all rehearsals and that students are in the space, ready to begin, upon the arrival of the Segerstrom Center for the Arts Teaching Artists.
- A commitment to the agreed upon rehearsal schedule, including managing schedules at the student, faculty and school levels to ensure organized and efficient use of School Team and Teaching Artists' time.
- An agreement to rehearse the play at least once a week for 90 minutes in addition to the rehearsal spent with the Segerstrom Center for the Arts Teaching Artists.
- An agreement to hold a minimum of four production meetings throughout the rehearsal process (one in week one, one to determine casting in week three, another in approximately week five, and the last in approximately week eight).
- An understanding that the school and/or School Team are responsible for the procurement of all materials necessary for the production.
- An understanding that, among other things, the School Team is responsible for classroom management of participating students and that the Segerstrom Center for the Arts Teaching Artists are present to lend their expertise and guidance to the project.
- An agreement to participate in and provide transportation to the Student Share Celebration at Segerstrom Center for the Arts on Monday, March 11, 2020. Specific School call time to be determined.
