Please see the following Additional Services request, for services related to gaining approval of the Foster Road Improvement Plans at the new Irene Snow Elementary School campus.

FOSTER ROAD FRONTAGE IMPROVEMENTS

Improvement plans for the Foster Road frontage at the new Irene Snow Elementary School campus were submitted in February, 2018 and comments were returned from City of Napa Public Works in May, 2018. Revised plans were resubmitted to in May 2019 and were returned with a second round of comments from City of Napa Public Works in June, 2019. Revised plans were again submitted in July 2019 and additional meetings and communication led to final approval in September, 2019. Additional services include the following, in summary:

1. Coordinate with City of Napa to negotiate extent of road repaving, number and size of water utility connections and meters, capacity fees required to be paid by the District, and relocation of an existing fire hydrant.
2. Revise site plans, enlarged site plans, and grading plans.
3. Provide mylars for recording with the City.
4. Provide documents for an easement related to the existing and new stormwater flow from Foster Road through the District’s property.
5. Revise Foster Road improvement drawings and submit revised plans to City of Napa.
