8. ACTION/INFORMATION ITEMS

a. Monthly District Cash Flow Update

Kimberly Smith, Director of Fiscal Services presented the following:

- The numbers of the presentation represented the revised adoption
- July September 2019 is based off actuals beginning with \$17,961,366.
- Total Revenue Cash inflow \$5,371,739.
- Total Expenditures Cash Outflow \$11,267,165.
- Payroll including benefits is 76% of total expenditures with \$8,534,297.
- Cash balance is \$13,072,902.
- The District did not take out a TRANS this year.

b. California Dashboard Local Indicators

Kermit Schrock, Program Administrator presented the following:

- Beginning in the fall 2017, as part of the California School Dashboard, all districts must go through an annual review of specific topics related to five of the state priorities and present an update to the Governing Board.
- Districts are doing self-reflections around basic services, teachers and materials, academic standards, etc.
- Self-study/self-reflection and then input that into the California Dashboard and this will have new release/gauges in December.
- LCFF Priority 1 Basic
 - Appropriately assigned teachers, access to curriculum-aligned instructional materials, and safe, clean and functional school facilities.
 - This priority was met.
- LCFF Priority 2 Implementation of State Academic Standards:
 Rate the LEA's progress in providing professional learning for teaching to the recently adopted academic standards and/or curriculum frameworks identified below:
 - Common Core State Standards for ELA.
 - English Language Development (ELD) Aligned to ELA Standards.
 - Common Core Standards for Math.
 - Next Generation Science Standards.
 - History-Social Science.
 - This priority was met.
- LCFF Priority 3-Parent and Family Engagement
 - Building Relationships:
 - *The District SEAL schools and DI classrooms, in particular, actively engage families in their child's instructional program. In addition, the District and schools have made intentional efforts in ELAC and DELAC meetings to engage families in an accessible manner around the key aspects of school and District plans.
 *In addition, the District is training staff and all administrators in addressing issues of equity and bias with the goal of establishing a supporting environment for all students and families.
 - *While the LCAP survey indicates that 83% of parents feel welcome in the school environment, we continue to focus on this to ensure that all families, particularly underrepresented groups, feel included in all aspects of their student's educational program.
 - Building Partnerships for Students Outcomes:
 - *Over the last several years, the District has implemented parent leadership training, such as Project2Inspire, particularly targeted for Spanish-speaking parents. In addition, the District partners with various community agencies to provide direct support to high needs families, including counseling services, food banks, parent workshops, and health resources.
 - *All elementary & middle schools hold parent conferences every fall to ensure parents and teachers have the opportunity to discuss student progress and ways parents can support their students.
 - *There continues to be a need to support schools and teachers to partner authentically with parents, particularly underrepresented families.
 - Seeking Input for Decision Making:
 - * The LCAP process for the district used a variety of venues and opportunities for families to engage in the decision-making process for the LCAP. The District

made a concerted effort to engage a more representational group of families through the survey, and had almost four times more participation that the previous year.

*In addition to the LCAP survey, meetings were scheduled for a number of groups/committees, in order to ensure additional input, particularly from English Learner and families with Special Needs students—District English Learner Advisory Committee(DELAC), Angeles Sin Fronteras, Superintendent Parent Advisory Council (SPAC), School Site Councils, Staff and Parent Club groups from each site and Parent Advisory Council (Migrant). These meetings were designed deliberately to allow families to access and engage in the major points of the LCAP and reflect on the specific actions the district has been taking.

*There is still a need to ensure that a larger representation of underrepresented families and groups are involved in these decision-making processes.

- This priority was met.
- LCFF Priority 6-School Climate:
 - District results are an average of grades 5, 7, 9 and 11. The California Healthy Kids Survey is administered every two years. The results of the CA Healthy Kids Survey for GUSD showed the following in the 17/18 Survey:
 - *71% of students report a high level of expectations.
 - *57% of students reported a high level of school connectedness.
 - *60% of students reported a high level of caring adult relationships.
 - *58% of students feel safe/very safe at school
 - This priority was met.
- Priority 7 Access to a Broad Course of Study:
 - Standard: LEAs annually measure their progress in the extent to which students have access to, and are enrolled in, a broad course of study that includes the adopted courses of study specified in the CA Education Code for grades 1-6 and grades 7-12, as applicable, including the programs and services developed and provided to unduplicated students and individuals with exceptional needs, and report the results to their local governing board at regularly scheduled meetings of the local governing board and to stakeholder and the public go through the Dashboard.
 - This priority was met.

a. Monthly Facilities, Maintenance And Operations Update

Paul Nadeau, Facilities Director presented on the following:

• The Gilroy High School pool is well underway, the demo is completely done.

b. Approval of Contract with Randazzo Enterprises, Inc. for the Demolition and Removal of Portables P1-P9 at Gilroy High School

 This item is for the demolition and removal of the P1-P9 portables at Gilroy High School.

c. Approval of Contract with Collins Electrical Company, Inc., to Remove All Electrical Power from Portables at Gilroy High School

 Collins Electric Co. will remove the power that is connected to portables P1-P9 at Gilroy High School, they will safe that area off.

d. Approval of Contract with NorCal Portable Services to Section Off Portables at Gilroy High School

 Portable services for fences that are surrounding that area for the project at Gilroy High School.

e. Approval of Ratification of Cost of Services with EF&S Concrete, Inc., for the Replacement of Failing Asphalt at Glen View Elementary School

- Changed the asphalt and concrete, did have a budget established in 2016, but did not proceed until now.
- The last few weeks, the asphalt at Glen View was coming apart.
- Cost of the project was \$86,160.

f. Approval of Ratification of Cost of Services with Architectural Systems, Inc., for the Exterior Egress and Exit Gate Work at Gilroy High School

Add new hardware and gates to Gilroy High School.

- Concerns at the site about being able to get off site guickly.
- Does meet code compliance all agree there could be more exit gates.
- Gilroy Police Department will do a review of what staff is proposing, which is adding crash bar equipment to each gate.
- Will add emergency exit signage to those areas as well.
- Cost of the project was \$43,925.

g. Approval of Contract with Anderson's Tree Care Specialists for the Removal of the Nuisance Pine Trees at Mt. Madonna High School

- In the back corner, behind the campus, there are several pine trees. They have become a nuisance, and they drop pine needles constantly.
- This does create a nice environment for fleas.
- This also creates a fire hazard.
- Have received approval from the City of Gilroy to take those out.
- Will replace, with different trees, possibly two trees per one tree that is taken out.
- Cost of project is \$14,980.

h. Approval of Contract with Anderson's Tree Care Specialists for the Structural Pruning of the Large Oak Tree at Solorsano Middle School

- That tree is quite overgrown and has not been properly maintained for quite some time.
- The tree is healthy just overgrown, and needs some structural weight reduction to preserve the safety and the length and the life of the tree.
- Cost of the project is \$5,000.

i. Approval of Contract with Val's Plumbing and Heating, Inc., for the Replacement of the Kitchen Swamp Cooler at Gilroy High School

- Prime source of cooling to the kitchen.
- This is the original equipment, it is about 16 years old.
- It is failed and disintegrated, and it is affecting the gutter system and the downspout near the kitchen.
- Cost of the project is \$13,996

j. Approval of Contract with Val's Plumbing and Heating, Inc. for the Replacement of the Gutter and Downspout Near the Kitchen at Gilroy High School

• Cost of the project is \$6,423.

k. Approval of Contract with EF&S Concrete, Inc. for the Replacement of the Damaged Concrete Driveway Approach and Apron at El Roble Elementary School

- City sidewalk reimbursement program no longer in place.
- That part of the sidewalk is failing.
- There were complaints from the community that it is a trip hazard.
- It is not an emergency repair.
- Would like to get this done during holiday break.
- Cost of the project is \$12,144.
