
TRAINING AGREEMENT

STANISLAUS COUNTY OFFICE OF EDUCATION SYLVAN UNION SCHOOL DISTRICT

This Training Agreement stands as evidence that the Sylvan Union School District (SUSD) will participate in the Positive Behavior Intervention and Supports (PBIS) Implementation Team Training to be delivered by the Stanislaus County Office of Education (SCOE).

The SCOE Prevention Programs Department has a proven history in providing professional development services to support student wellness and school safety. These services include a variety of training programs and technical assistance on topics such as suicide prevention, mental health, school safety planning and crisis response, bullying prevention and Positive Behavioral Interventions and Support. The Department employs a team of subject matter experts with training and experience in delivering these specialized training programs.

This scope of work outlines the agreement and provides detailed information on the activities to be completed:

Period: July 1, 2019 through June 30, 2020

Services: SCOE will deliver a four-day training for one Tier 2 site. This will prepare school teams to implement PBIS. Each year focuses on a different tier of implementation, with a final goal to implement all three tiers following three years of training.. Training days are scheduled and dates have been provided to all participating school sites.

- Somerset Middle School will participate in Tier 2 training.

Cost: \$6,000 for one SUSD Tier 2 training for a total of \$6,000; includes the cost of all four training days, materials and a full lunch meal for all participants. (SCOE will invoice SUSD for 25 percent of the total cost upon execution of this contract, and the remaining balance after the final day of training.)

The overall total for PBIS training and safety consulting will be \$6,000.

Agency Commitments:

Stanislaus County Office of Education

- Host and deliver four full-day training sessions for Tier 2 PBIS Implementation
- Provide all training materials and training meals
- Provide follow-up technical assistance and support to ensure training meets the needs of the implementation team.

Sylvan Union School District

- Complete the ongoing implementation activities as assigned in the training program
- Ensure site implementation team members participate in each of the four days of training
- Designate a site contact to serve as the liaison between the SCOE training team and the site implementation team.
