During the 2019-2020 school year, approximately 396 students were enrolled in kindergarten through fifth grade. Cleaning Process: Woodrow Elementary School strives to maintain a safe, healthy, nurturing and orderly school campus that encourages positive attitudes in students and staff. The district governing board has adopted cleaning standards for all schools in the district. Schools are on a regular cleaning schedule including wiping surface areas, being swept or vacuumed and the trash emptied. The cafeteria, gym, and all restrooms are cleaned daily. Grounds are groomed on a rotating basis with trash, lawn, and plumbing issues addressed as needed.

Maintenance and Repair: Woodrow Elementary School is in good repair and the site is being maintained to the standards of the Sylvan Union School District. Asphalt in rear of site completely removed and replaced, drainage corrected and all other asphalt seal coated and striped. Detective work continues on a sewer drainage issue on east end of site. Woodrow is in good repair and is ready for learning activities daily.

School Safety Plan (School Year 2019-20)

Woodrow Elementary School has adopted a comprehensive School Safety Plan that is reviewed and updated annually by members of the School Site Council. The Site Council is comprised of teachers, classified staff, parents, and the principal. The Safety Plan for the 2018-2019 school year was formally approved by the school's School Site Council on 2/19/2019. The school staff suggested final changes and had input on new assignments at the 8/7/2018 staff meeting. The revised Safety Plans are presented to the Sylvan Union School District Board of Trustees for annual review and approval. The Safety Plan is reviewed with staff members at the beginning of each school year with particular attention paid to emergency situations and staff and student responses. Safety drills, including fire, earthquake, and lockdown procedures, are held regularly. In addition, the school is inspected annually by the fire marshal and daily by the custodian. All issues discovered during these inspections are given the utmost priority. Copies of the comprehensive School Safety Plan are posted in each classroom and office area.
