### **AMENDMENT NUMBER 1 TO AGREEMENT FOR PROJECT MANAGEMENT SERVICES WITH TELACU CONSTRUCTION MANAGEMENT, INC.**

This Amendment shall be incorporated in that certain document dated January 24, 2017 entitled, “Agreement for Project Management Services between Ravenswood City School District and TELACU Construction Management, Inc. (“Agreement”). The parties desire to amend the Agreement pursuant to Article 3 of the Agreement. Where any Article or portion is amended or superseded, the balance of that Article or portion not specifically amended or superseded shall remain in effect as originally written. Where any Article or portion thereof is supplemented, that supplement shall be considered added thereto, and the original provisions of the Article shall remain in effect as originally written. Where any Paragraph or Section is referenced, such Paragraph or Section is superseded and replaced by the language herein. This Amendment, taken together with the Agreement dated January 24, 2017, represents the new contract for Program/ Construction Management Services. The terms and provisions of the Agreement are hereby amended and supplemented as follows:

#### ***Extend the term of the Agreement as follows:***

The current term of the Agreement will expire on December 31, 2019. The Ravenswood City School District (“Owner”) desires to extend the term of this Agreement in accordance with Article 3 starting on January 01, 2020 and ending December 31, 2020.

By executing this Amendment, Construction Manager agrees and acknowledges that it has been paid in full for all Services performed and all costs incurred during the current term of the Agreement through November 30, 2019, including all costs set forth in Appendix “A” to the Agreement less the Current Contract Balance (2019 Year).

#### ***Add the attached Appendix “A” to the Agreement***

Appendix “A” to the original Agreement shall be supplemented with the attached Appendix “A” to cover the costs for project management Services pursuant to the Agreement for the extension covered by this Amendment. The Scope of Work/ Services portion of the original Appendix “A” shall remain.

#### ***Add the following to Article 2.1 of the Agreement***

Total compensation for the extension covered by Amendment Number 1 (2020) for all Services under the Agreement shall be as set forth in the attached supplemental Appendix “A”.
