**Resolution No. 819**  
**Reconfiguration of Rio Linda Preparatory Academy**

**WHEREAS**, the **TWIN RIVERS UNIFIED SCHOOL DISTRICT** has encountered a budgetary impact based on declining enrollment and approval of Superintendent's recommendation to implement necessary fiscal measures, facility and program reconfigurations, school consolidations and other prudent actions to best preserve fiscal integrity and increase student achievement at the Twin Rivers Unified School District; and

**WHEREAS**, the District recognizes the need to reconfigure schools to provide the best academic and support environment for our students now and in the future; and

**WHEREAS**, the Trustees have a fiduciary responsibility to meet its obligation and at the March 26, 2019, regular Board Meeting approved Resolution 756, which are incorporated herein by reference;

**WHEREAS**, the District will implement an additional \$5.7 million (\$3.7 million if the Governor's Budget proposal for Special Education is approved in June 2020) in budget reductions and/or revenue enhancements in 20-21; and

**WHEREAS**, the Trustees received and reviewed numerous student housing committee reports and administrative recommendations the Board approved factors for schools to be reconfigured on July 2, 2019; and

**WHEREAS**, there is a desire to enhance equitable access to educational programs, to protect and improve the integrity of District instructional programs, and provide for the general health, safety and welfare of the student populations K-12; and

**WHEREAS**, the below recommendation is presented by the District's Executive Leadership Team.

**NOW, THEREFORE, BE IT RESOLVED**, that this Board will provide the resources necessary to ensure an optimal environment for teaching and learning and District Administration shall work directly with affected school sites, parent groups and communities, in order to maximize the success of the school consolidations and reconfigurations; and

**BE IT FURTHER RESOLVED**, that the Board of Trustees approves the reconfiguration of *Rio Linda Preparatory Academy from 5-8 to 7-8 over two years* – Effective 2020-2021 School Year.

- a. Rio Linda Preparatory Academy 6-8 in 2020/2021 school year
- b. Rio Linda Preparatory Academy 7-8 in 2021/2022 school year
