### EARLY CHILDHOOD EDUCATION TEACHER (HEAD START, FULL DAY)

#### OVERALL RESPONSIBILITY

Under general supervision, ensure that all students are provided with a compliant integrated, and coordinated child development program based on student needs and specific programmatic requirements.

#### SPECIFIC RESPONSIBILITIES

1. Develop and maintain a classroom learning environment that incorporates Federal, and District, and program goals and objectives. E
2. Teach within the prescribed course of study. E
3. Establish and maintain a classroom management system that is efficient and effective. E
4. Identify each child's instructional needs through an on-going use of formal and informal assessment processes. E
5. Develop and implement an instructional plan for each child that addresses the child's specific needs and interests. E
6. Evaluate each child's performance on a systematic basis, and report the child's progress to his parent/guardian. E
7. Develop and initiate parent education activities. E
8. Adhere to program enrollment procedures. E
9. Prepare and maintain classroom records in accordance with Federal and State law, and local District policies. E
10. Plan and coordinate daily instructional activities as evidenced by written lesson plans and staff work schedule. E
11. Plan and coordinate the work of instructional paraprofessionals, parent volunteers and other designated volunteers in accordance with Federal and State laws. E
12. Participate in staff development activities in accordance with Federal and State laws. E
13. Provide and maintain required adult supervision of students in indoor and outdoor learning environments. E
14. Effectively communicate and maintain cooperative relationships with those contacted in the course of work.
15. Perform other related duties as assigned.
