## AMENDMENT NO. 1 TO AGREEMENT FOR PROFESSIONAL SERVICES WITH STAR ARTS EDUCATION

In connection with the Agreement for Professional Services dated as of December 19, 2019 (the "Original Agreement") between the GILROY UNIFIED SCHOOL DISTRICT ("District") and **STAR Arts Education** ("Consultant"), which consists of the Original Agreement, the Proposal relating to the Original Agreement, the District's Request for Proposals dated January 30, 2020 and several Exhibits, the Consultant and the District hereby amend the Original Agreement pursuant to this Amendment No. 1 (the "Amendment," and together with the Original Agreement, the "Agreement"), by and between the District and the Consultant, as follows:

- 1. **Compensation**. The amount specified as compensation in **Paragraph 4** of the Original Agreement is hereby deleted and replaced with the following amount: \$62,000. Payment of the fee shall remain subject to the agreed-upon Compensation specified in the Original Agreement and the rates or schedule of fees specified in **Exhibit B** thereto.
- 2. **Services**. The services described in **Exhibit A** of the Original Agreement are hereby amended. The revised **Exhibit A** is incorporated herein by this reference.

The Services described herein do constitute additional services within the meaning of the Original Agreement.

- 6. **Execution**. The person(s) executing this Amendment on behalf of the Consultant warrants and represents that Consultant has vested authority on such person(s) to execute and deliver this Agreement
