**Re:** Consideration to Approve Change Order #3 with Beals & Martin, Inc. for the Ravenswood Middle School Realignment - Phase 1

**QUICK SUMMARY/ABSTRACT:**

RCS D Administration in conjunction with SVA Architects have requested several proposals from Beals & Martin for various change orders over the course of the construction effort for the Ravenswood Middle School Realignment- Phase 1.

Beals & Martin began construction in March of 2019. There were necessary design changes required during construction due to unforeseen existing conditions and design changes with the Science building, locker rooms and music room. There have been two (2) change orders approved and issued to date.

- Change Order #1 = \$ 109,116.00
- Change Order #2 = \$ 49,018.00

This consideration is for Change Order #3. The Proposed Change Orders (PCO's) were approved by the Architect, Telacu Construction Management, and the District office and are summarized in the attachment. Based on the review and discussions of the proposed change order, the recommendation is to approve Change Order #3 to Beals & Martin, Inc., in the amount of \$ 234,773.00.

**RATIONALE:**

This is the next part of the continuing improvements to the Ravenswood Middle School campus, which one of the goals is ensuring that our students have a safe environment. This project will achieve this by providing a new science building, music room and renovated locker rooms.

**FINANCIAL IMPACT:**

The total cost of this change order is \$ 234,773.00, which will be funded through Measure H & S bond funds.

**RECOMMENDATION:**

It is recommended that the Board of Trustees approve Change Order #3 to Beals & Martin, Inc.
