One keynote presentation for the tfaculty and staff of the Sylvan Union School District (up to 60 minutes).

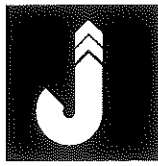

Term/Termination

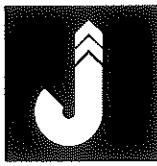
Cancellation Policy:

If the engagement is canceled by the organization, any travel-related expenses incurred by the Jeremy Anderson Group, LLC are to be reimbursed and the following schedule percentage of the fee will be in effect from the time the written notification is received:

31-60 days prior to scheduled engagement: 50%
