After School Education and Safety Program Mid-Year Evaluation March 25, 2020

The purpose of these visits is to monitor the program being offered by the Boys' and Girls' Club of Sonoma-Marin.

Consistent programming was observed at all sites visited. The day is divided into Power Hour, Supper, and Programs. During Power Hour students were receiving homework support. Students appeared engaged.

During Supper time, all students attending the program eat together. Food consists of cold, pre-packaged items. Students, seem to enjoy the meals offered as evidenced by few leftovers. After Supper students are dismissed to their chosen program for the remainder of the day.

Programs consist of a variety of activities including, soccer, practicing for a Talent Show, makers class, art, and yoga. Activities varied at each site.

Students are signed in each day and parents sign their child out at pick up time. The staff communicates with each other by walkie talkie and this is consistent at each site.

In speaking to program directors, site administrators and a few teachers, the ASES program, being provided by the Boys and Girls Club of Sonoma-Marin has been well received. All ASES principals would like to retain Boys & Girls Club of Sonoma-Marin as their ASES provider. Shown below is how the ASES program was evaluated by the ASES principals along with the dates of Coordinator's site visits for 2019 - 2020.
