RESOLUTION OF THE BOARD OF EDUCATION OF THE BERKELEY UNIFIED SCHOOL DISTRICT CANVASSING THE RESULTS OF GENERAL OBLIGATION BOND ELECTION HELD WITHIN THE DISTRICT ON MARCH 3, 2020

, the following Resolution is adopted:						

WHEREAS, the Board of Education ("Board") of the Berkeley Unified School District ("District"), County of Alameda ("County"), State of California ("State"), previously adopted its Resolution # 20-016 ordering the County Registrar of Voters ("County Registrar") to call an election for general obligation bond authorization (designated as "Measure G") (the "Bond Election") to be held within the District on March 3, 2020; and

WHEREAS, the Bond Election was called pursuant to the provisions of the California Constitution and State law, including, but not limited to, the terms and conditions of the "Smaller Classes, Safer Schools and Financial Accountability Act," also known as "Proposition 39," and related State legislation; and

WHEREAS, Resolution 20-046 was duly delivered to the County Registrar and County Clerk of the Board of Supervisors ("County Clerk"); and

WHEREAS, notice of the Bond Election was duly given; and

WHEREAS, on March 3, 2020, the Bond Election was duly held and conducted for the purpose of voting on a Measure G to authorize the issuance of bonds of the Berkeley Unified School District in the amount not to exceed \$380,000,000 (the "Bond Measure"); and

WHEREAS, the Board of the District has received from the County Registrar the Certification of Election Results for the Bond Measure; and

WHEREAS, it appears from the Certification of Election Results, a copy of which is attached hereto as Exhibit "A," and incorporated herein by this reference, that fifty-five percent (55%) or more of the votes cast on such measure were in favor of the Bond Measure.

NOW, THEREFORE, THE BOARD OF EDUCATION OF THE BERKELEY UNIFIED SCHOOL DISTRICT DOES HEREBY RESOLVE, DETERMINE AND ORDER AS FOLLOWS:

- **Section 1.** <u>Entry Upon Minutes</u>. That entry be made upon the minutes of this meeting that the Bond Measure has been approved by fifty-five percent (55%) or more of the votes cast at the Bond Election.
- **Section 2.** <u>Determination of Validity</u>. That the Board determines that all proceedings of the Berkeley Unified School District in connection with the Bond Election have been accomplished according to law.
- **Section 3.** <u>County Filing.</u> That the Clerk of the Board is hereby directed to deliver, or cause to be delivered, a copy of this Resolution to the County Superintendent of Schools and to the Board of Supervisors of the County.
