## 8. HUMAN RESOURCES

### 8.1. Resolution No. 20/19-20 for Reduction of Classified Services for 2020-2021 (v)

Sue Wieser, Assistant Superintendent of Human Resources presented Resolution No 20/19-20 listing Classified employees that may be laid off due to lack of work or lack of funds in the 2020-2021 year. She noted that these are mostly positions funded by the Parent Teacher Associations (PTAs) and that they haven't determined their available funding yet. However, the District will be able to place the impacted staff in other positions. Nevertheless, in order to meet the 60-day layoff notices, the recommendation is to reduce the positions at this time.

Trustee Chin appreciated the update. He noted that these are difficult times and unfortunately, the PTAs had to cancel many of their fundraising activities due to the current situation. He was glad to hear that the District is reaching out to the impacted staff members.
