

**MEMORANDUM OF UNDERSTANDING**  
**BETWEEN**  
**CHAN ZUCKERBERG INITIATIVE, LLC AND**  
**RAVENSWOOD CITY SCHOOL DISTRICT**

**1. Parties.**

This Memorandum of Understanding (hereinafter referred to as “MOU”) is made and entered into by and between the Chan Zuckerberg Initiative, LLC (“CZI”) and the Ravenswood City School District (“RCSD”) on March 18, 2020 (“Effective Date”).

**2. Background of Parties.**

CZI is a philanthropic organization that brings together world-class engineering, grant-making, impact investing, policy, and advocacy work in a variety of areas.

RCSD is a public school district and local educational agency headquartered in East Palo Alto, California.

**3. Purpose and Project Description.**

The purpose of this MOU is to identify the roles and responsibilities of CZI and RCSD as it relates to the provision and support of Verizon MiFi devices (“Devices”) to RCSD for the use of its students during school closures related to COVID-19 (“Program”).

Specifically, through the Program, CZI intends to provide Devices and volunteer technical resources (at no cost) in order to support RCSD and its students.

**4. Roles and Responsibilities.**

It is anticipated that CZI and RCSD will work toward the coordinated implementation of the Program in accordance with the following structure.

CZI will:

- a. Obtain 300 Inseego Jetpack MiFi 8800L devices as identified in Exhibit A (“Devices”) from Verizon Wireless and provide the Devices to RCSD for the Program Term (defined below);
- b. Provide cellular data service for the Devices through Verizon Wireless. Each device will have 2GB of cellular data available per month;
- c. Provide RCSD with access to a remote management portal provided by Verizon Wireless. CZI is not responsible for the remote management portal, but will endeavor to provide support to RCSD in its use of the portal including access to training that may be available through Verizon Wireless;

- d. Communicate (or assist in communication) with Verizon Wireless if there are any coverage or functionality issues. CZI is otherwise not responsible for any coverage or functionality issues related to the Devices;
- e. Monitor aggregate data usage per device to manage potential data overages; and
- f. Not access any information associated with the Devices that might constitute student personally identifiable information (such as geolocation) unless at the separate instruction of RCSD. The Devices are subject to the Verizon Wireless [Privacy Policy](https://www.verizon.com/about/privacy/) (available at <https://www.verizon.com/about/privacy/>), and CZI has no control or responsibility over the Verizon Wireless Privacy Policy.
- g. Notwithstanding the above, CZI may access Device information, including student personally identifiable information, if required to investigate abuse, protect or defend the rights or safety of CZI, RCSD, or its students, to comply with law enforcement, legal or regulatory process, or to comply with applicable laws.

RCSD will:

- h. Arrange to receive delivery of the Devices;
- i. Manage the delivery and return of Devices to and from students;
- j. Provide any necessary technical support to students;
- k. Notify CZI if there are any coverage or functionality issues so that CZI can communicate with Verizon;
- l. Return the Devices to CZI upon the completion of the Program Term (defined below) in compliance with the instructions provided by CZI's Program Team;
- m. Only use the Devices for the purpose of supporting distance learning of its students during the Term of the Program;
- n. Not provide CZI with any student personally identifiable information (such as which students are assigned to a given Device);
- o. Not rent, lease, loan, trade, sell/resell or otherwise monetize the Devices;
- p. Not manipulate or alter any firmware or software on the Devices; and
- q. Ensure the Devices are not used for illegal purposes by its students or employees.

Both parties jointly will:

- r. Appoint a key contact person for the Program;
- s. During the Term of the MOU, maintain frequent communication through the key contacts to facilitate cooperation under this MOU;
- t. During the Term of this MOU, coordinate through the key contacts to determine appropriate timelines for Program updates and status reports (if any); and
- u. Coordinate joint communication efforts to ensure that any communication is consistent with the respective parties' policies regarding such communication.

## **5. Warranties; Limitation of Liability.**

- a. Warranties. Each party hereby represents and warrants that it has the right, power, and authority to enter into this MOU and perform its obligations hereunder. Each party shall be solely and

exclusively responsible and liable for its compliance with applicable law and regulations in connection with the performance of its obligations hereunder. EXCEPT AS EXPRESSLY SET FORTH IN THIS MOU, EACH PARTY HEREBY DISCLAIMS ANY AND ALL WARRANTIES AND CONDITIONS, EXPRESS, IMPLIED, OR OTHERWISE, INCLUDING ANY IMPLIED WARRANTIES OF MERCHANTABILITY, NONINFRINGEMENT, TITLE, AND FITNESS FOR A PARTICULAR PURPOSE.

- b. Limitation of Liability. EACH PARTY SHALL BE LIABLE TO THE OTHER PARTIES FOR ITS OWN PERFORMANCE UNDER THIS MOU. NOTWITHSTANDING THE FOREGOING, IN NO EVENT SHALL ANY PARTY BE LIABLE TO ANY OTHER PARTY IN CONNECTION WITH THIS MOU FOR ANY CONSEQUENTIAL, INCIDENTAL, INDIRECT, SPECIAL, OR RELIANCE DAMAGES (OR ANY LOSS OF REVENUE OR PROFITS), HOWEVER CAUSED, WHETHER FOR BREACH OF CONTRACT, NEGLIGENCE OR UNDER ANY OTHER LEGAL THEORY, WHETHER FORESEEABLE OR NOT AND WHETHER OR NOT SUCH PARTY HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.

**6. Term and Termination.**

- a. Term. This MOU will commence on the Effective Date and remain in effect for three (3) months unless earlier terminated by all parties (the “*Term*”). The Term can be extended for an additional three (3) months if agreed to by both parties at least 2 weeks before the expiration of the Term.
- b. Survival. Sections 5, 6(b), and 7 shall survive the expiration or termination of this MOU.

**7. General Provisions.**

- a. Confidentiality. No party will disclose to a third party the nature of this MOU without the prior written consent of all parties to this MOU, unless: (1) the information is made publicly available from other sources; or (2) the disclosure is required by law.
- b. Notices. Any notice, consent, or approval related to this MOU shall be in writing and shall be sufficiently given if delivered or transmitted to:

- c. Promotion. Except as may be expressly provided in this MOU, the parties may not use the other party's name, logo, and other marks without such other party's prior written consent. Any content publicly describing the relationship between or among the parties, including press releases, blog posts, and similar media, will be subject to the mutual written agreement of the parties. Any goodwill associated with a party's use of any other party's marks will inure solely to the benefit of the owner of such marks.
- d. Relationship. The relationship of the parties is that of an independent contractor (and not an agent or representative) in the performance of this MOU. This MOU will not be interpreted or construed as: (1) creating or evidencing any association, joint venture, partnership, or franchise among the parties; (2) imposing any partnership or franchise obligation or liability on either party; or (3) authorizing either party to bind the other to any agreement or obligation.
- e. Assignment. No party shall assign this MOU or any right, interest, or benefit hereunder without the prior written consent of all other parties. Notwithstanding the foregoing, a party may assign this MOU without the other parties' consent to any person or entity that acquires or succeeds to all or substantially all of such party's business or assets relating hereto.
- f. Governing Law; Disputes. This MOU will be governed by California law without regard to conflicts of laws principles. Should a dispute arise between or among any of the parties relating to this MOU, senior executives of each disputing party shall in good faith attempt to resolve the dispute within 30 calendar days following receipt of written notice sent by one disputing party to the other disputing party(ies). If there is no resolution within such 30-day period, any disputing party may submit to the other party(ies) a written demand for confidential arbitration. All claims will be subject to confidential and binding arbitration if, and only if, the claim is not settled through informal dispute resolution. The parties agree that any dispute subject to arbitration shall be held in San Mateo County, California in accordance with the rules then in effect of the American Arbitration Association.
- g. Entire MOU; Amendment; Waiver. This MOU sets forth the entire agreement between and among the parties with respect to the subject matter hereof and may only be amended in a writing signed by all parties. No provision of this MOU may be waived except by a writing signed by the party against whom the waiver is to be effective. This MOU may be executed in counterparts, each of which shall be deemed an original.
