RE: **Regular Governing Board Member
Presidential General Election Tuesday, November 3, 2020**

The Regular Governing Board Member General Elections, in accordance with the provisions of the Education Code, are scheduled to be held on Tuesday, November 3, 2020, in all California School Districts.

The Education Code provides that when there are two or more districts of any type in an area in which governing board elections are to be held, the elections shall be consolidated, and the County Superintendent of Schools shall notify the governing boards that consolidated elections are required (Education Code Section 5323, 5340). This notification is enclosed.

The following information is important for all districts in Stanislaus County:

Resolution Ordering Governing Board Member Election: Please Note the following:

1. Each governing board must adopt a resolution at their June Board meeting containing "Specifications of the Election Order" and deliver the following information to the County Superintendent of Schools on or before **July 2, 2020**:
 - A. **Resolution:** one copy
 - B. **Agenda:** two copies of the board meeting which lists this as an action item

We are enclosing a copy of the partially completed form, which the district may use for its resolution. The polling places and election officials have been determined by the Office of the County Clerk.

Important Notice - Candidates may submit a statement of qualifications to be sent to each voter. A deposit will be collected from each candidate who submits a statement. *The statement is permissive, not mandatory.*

For the above reasons, it has been deemed advisable to have candidates pick up the proper forms at the office of the County Clerk of Stanislaus County, Registration and Elections Department, 1021 "I" Street, Suite 101, Modesto, California, and file the completed candidacy form in person at the time the Declaration Form is obtained.

► **NOTE:** *The filing period for interested parties to file declarations of candidacy is **July 13 to August 7, 2020, by 5 p.m.** Any questions may be directed to the Registration and Elections Department, by calling (209) 525-5200.*


