ELIMINATION OF FOURTEEN CLASSIFIED POSITIONS

RESOLUTION NO. 53

WHEREAS, the Board of Education of the Alvord Unified School District hereby determines that the following classified positions be reduced due to lack of work and/or lack of funds in accordance with Education Code Section 45117;

NOW, THEREFORE, it is hereby resolved and ordered by this Board of Education:

1. The Superintendent recommends that the Governing Board adopt a resolution to eliminate fourteen classified positions as follows:

BE IT FURTHER RESOLVED by the Board of Education as follows:

1. That due to a lack of work and/or lack of funds, the classified positions above shall be reduced by a layoff as specified above, pursuant to Education Code Sections 45118 and 45308 and Article XV of the collective bargaining agreement between the District and California School Employees Association, and its Alvord Chapter 339.
2. That the Superintendent or designee is directed to give notice of layoff to the affected classified employees to the requirement of law.
3. That said lay off shall become effective sixty (60) days after notification to the affected employee.
4. That employee laid off pursuant to the resolution shall be eligible for re-employment pursuant to Education Code 45298.
